#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter One Hundred Ninety-seven of the Public Laws of Nineteen Hundred Seventeen as Amended by Chapter One Hundred Seventy-two of the Public Laws of Nineteen Hundred Nineteen Relating to the State Department of Health.

Be it enacted by the People of the State of Maine, as follows:

Section four of chapter one hundred ninety-seven of the

- 5 said section and substituting therefor the following:
  - 'Sect. 4. Public health council, membership and qualifica-

2 tions, tenure of office, vacancies, etc.; meetings and duties. 3 The public health council shall consist of a commissioner of 4 health and five other members hereinafter called the ap-5 pointive members, two of whom shall be physicians, and 6 one a dentist, all of whom shall be appointed by the govern-7 or with the advice and consent of the council. On or before 8 the first day of May in the year nineteen hundred twenty-9 three, the governor with the advice and consent of the 10 council shall appoint a dentist as a member of said board to hold office for the term of four (4) years from said 12 first day of May, 1923, and at the same time shall make 13 another appointment to said board for the term of five (5) 14 years from said first day of May, 1923, and thereafter all 15 appointments to said board except to fill vacancies shall be 16 for the term of five years from the first day of May of the 17 year of their appointment. Vacancies shall be filled by 18 appointment of the governor with the advice and consent 19 of the council for the unexpired term. The public health 20 council shall meet at least once in each month and at such 21 other times as they shall determine by their rules, or upon 22 the request of any three members, or upon request of the 23 commissioner of health. It shall be the duty of the public 24 health council to make and promulgate rules and regulations 25 in furtherance of the public health law; to consider plans 26 and appointments required by law; to submit annually to 27 the legislature through the governor a report, including 28 recommendations as to needed health legislation; and to 29 discharge other duties required by law, but it shall have no 30 administrative or executive functions.'
