STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter Thirty-one of the Private and
Special Laws of Nineteen Hundred and Five, Entitled "An
Act to Authorize the Houlton Water Company to Generate,
Sell and Distribute Electricity," as Amended by Chapter
Three Hundred and Forty-eight of the Private and Special
Laws of Nineteen Hundred and Nine.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of said act is hereby amended by
2 inserting after the word "New Limerick" in the eighth line
3 in said section the following, 'Ludlow, Smyrna, Merrill,
4 Dyer Brook, Oakfield,' so that said section as amended
5 shall read as follows:

'Sect. 1. The Houlton water company is hereby specially
2 authorized and empowered to contract for, buy, make,
3 generate and use electricity upon its property in the town
4 of Houlton, in the county of Aroostook, or other property
5 hereafter acquired by said Houlton water company for the
6 purpose, and to transmit, conduct, and distribute such elec-
7 tricity to, into and throughout the town and village of said
8 Houlton and the towns and villages of Linneus, Hodgdon,
9 New Limerick, Ludlow, Smyrna, Merrill, Dyer Brook, Oak-
10 field, and Hammond Plantation, and sell and supply the
11 same for lighting such public streets and such buildings
12 and places therein, public and private, as may be agreed
13 upon by said company and the owners or those having
14 control of such streets and places to be lighted, and may
15 transmit, sell and supply the same for heating, motive
16 power, manufacturing or mechanical purposes in said towns
17 and said plantation.'

Sect. 2. Section two of said act is hereby amended by
2 inserting after the word "New Limerick" in the ninth line of
3 said section the words, 'Smyrna, Merrill, Dyer Brook, Oak-
4 field,' so that said section as amended shall read as follows:

'Sect. 2. Said company is hereby authorized and em-
2 powered to build, erect and operate manufactories and
3 works, for making, generating, distributing and supplying
4 electricity upon said property, to use the same therein, and
5 to erect, lay down, construct, maintain and operate lines of
6 wires or other material for the transmission of electricity

7 under, over and across any stream or river, and under,
8 along, upon and over the streets, ways and bridges in said
9 towns of Houlton, Linneus, Hodgdon, Ludlow, New Lim-
10 erick, Smyrna, Merrill, Dyer Brook, Oakfield and said
11 Hammond Plantation.'
