STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE • HUNDRED AND TWENTY-THREE

AN ACT to Repeal the Act Organizing the Plantation of Elliottsville.

Be it enacted by the People of the State of Maine, as follows:

Section 1. So much of chapter one hundred and twenty-

- 2 three of the private and special laws of the state of Maine,
- 3 of 1895, approved March 5, 1895, entitled "An act to or-
- 4 ganize certain plantations" as relates to Elliottsville plan-
- 5 tation, being the former township No. 8 range 9, north of
- 6 Waldo Patent, is hereby repealed.

Provided, however, that the organization, existence, pow-

- 2 ers, duties and liabilities of said plantation shall survive
- 3 for the purpose of prosecuting and defending all pending

4 suits, and cases of suits, to which said plantation is or 5 may be party, and all needful processes growing out of 6 the same; and for the further purpose of providing for 7 the payment of any or all judgments, which may be re-8 covered against such plantation.

Sect. 2. Disposition of Unexpended School Funds:

All funds unexpended, or due, at the time when this act 2 is effective, out of amounts raised by said plantation for 3 school purposes, or out of amounts paid by the state for 4 such purposes, shall be paid by the treasurer of said 5 plantation, or such other person in whose custody such 6 funds may be, to the treasurer of the state.

Such amounts, so received, shall constitute a fund for 2 school purposes of which the income only shall be expended 3 and applied for the schooling of children resident within 4 the limits of the present plantation.

Sect. 3. Date when effective.

This act shall take effect and be in force from and after 2 the first day of March in the year of our Lord one thousand 3 nine hundred and twenty-four.

STATEMENT OF FACTS

Elliottsville plantation is located in Piscataquis county, and was formerly township No. 8 Range 9, north of Waldo Patent. It was incorporated as a town March 22, 1836, incorporation repealed February 24, 1885; organized as a plantation for school purposes by meeting of the inhabitants held June 21, 1886, whose doings were made legal by act of legislature March 2, 1887; organized as a plantation for general purposes by legislature March 5, 1895.

It has a population of 65, and valuation of about \$95,000. It is a wild land, or timber, plantation.
