**IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-THREE**

AN ACT Directing the State Board of Veterinary Examiners to Issue Certificate to Joseph R. Waller to Practice Veterinary Surgery, Medicine or Dentistry.

---

Whereas there is a lack of veterinarians in the eastern part of the county of Washington and whereas Joseph R. Waller is available for such practice in said county of Washington and state of Maine, but unaware of law, omitted to register under provisions of § 4, chapter 17 of public laws of 1905 and of chapter 18 of public laws of 1911 now, therefore,

---

Be it enacted by the People of the State of Maine, as follows:

Joseph R. Waller of St. Stephen, county of Charlotte,

2 province of New Brunswick may, on or before sixty days  
3 from the time this act shall take effect, pay to the treasurer  
4 of the state board of veterinary examiners a fee of five  
5 dollars, register his name and address with said board with  
6 proof that he was engaged in the practice of veterinary  
7 surgery, medicine or dentistry, or any branch thereof, in  
8 this state on the twenty-second day of February, one thou-  
9 sand nine hundred and five, and thereupon, said board  
10 shall issue to said Joseph R. Waller a certificate signed by  
11 the president and secretary, authorizing said Joseph R.  
12 Waller to practice veterinary surgery, medicine, or den-  
13 tistry, or any branch thereof, within the state and said  
14 certificate shall be recorded in the office of the clerk of the  
15 supreme judicial court for the said county of Washington  
16 and in the absence of the original certificate an attested  
17 copy of such record shall be received as evidence in all  
18 courts within the state of the right of said Joseph R.  
19 Waller to practice veterinary surgery, medicine or dentistry,  
20 or any branch thereof, within the state.
