STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter Sixty-nine, Public Laws of Nine-
teen Hundred Twenty-one, Relating to the Fiscal Year of
the State.

Be it enacted by the People of the State of Maine, as follows:

Section two of chapter sixty-nine of the public laws of
2 nineteen hundred twenty-one is hereby amended by adding
3 thereto the following: 'Provided, however, that this section
4 shall apply to the state highway commission only so far
5 as it relates to a report of its fiscal affairs and the report
6 of its highway and bridge construction and maintenance
7 work shall be for and cover the calendar year next prior
8 to the date of such report which shall be transmitted to

9 the secretary of state on or before the thirty-first day of
10 December in each year,' so that said section as amended
11 shall read as follows:

'Sect. 2. All departments now required by law to submit
2 an annual or biennial report shall, beginning July first, nine-
3 teen hundred and twenty-two, submit such report annually
4 or biennially as required by law for the fiscal year or years,
5 defined above. Provided, however, that each department
6 required to make an annual report shall on July first, nine-
7 teen hundred and twenty-two, submit a report for the eight-
8 een months beginning January first, nineteen hundred and
9 twenty-one, and ending on June thirtieth, nineteen hundred
10 and twenty-two, and each department required to make a
11 biennial report shall on the first day of July, nineteen hun-
12 dred and twenty-two, submit a report for the eighteen
13 months beginning January first, nineteen hundred and twen-
14 ty-one, and ending June thirtieth, nineteen hundred and
15 twenty-two. Provided, however, that this section shall ap-
16 ply to the state highway commission only so far as it relates
17 to a report of its fiscal affairs and the report of its highway
18 and bridge construction and maintenance work shall be for
19 and cover the calendar year next prior to the date of such
20 report which shall be transmitted to the secretary of state
21 on or before the thirty-first day of December in each year.'
