STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Regulate the Sale of Vinegar.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No person shall, within this state, manufac-

- 2 ture, sell, distribute, transport, offer or expose for sale, dis-
- 3 tribution or transportation, any product known as vinegar
- 4 which is adulterated or misbranded within the meaning of
- 5 this act.
 - Sect. 2. DEFINITIONS. The terms "cider vinegar,"
- 2 "apple vinegar" shall be construed to mean the product made
- 3 exclusively from the expressed juice of clean, whole apples,
- 4 by alcoholic and subsequent acetous fermentations, the acid-

- 5 ity, solids and ash of which have been derived exclusively
- 6 from the apples from which it was fermented.

The term "sugar vinegar" shall be construed to mean the product made by the alcoholic and subsequent acetous fer-

- 3 mentations of solutions of sugar, syrup, molasses or re-
- 4 finer's syrup.

The term "malt vinegar" shall be construed to mean the 2 product made by the alcoholic and subsequent acetous fer-

3 mentations of an infusion of barley malt.

The terms "wine vinegar" and "grape vinegar" shall be 2 construed to mean the product made by the alcoholic and 3 subsequent acetous fermentations of the juice of grapes.

The term "glucose vinegar" shall be construed to mean the 2 product made by the alcoholic and subsequent acetous fermentations of solutions of corn sugar or glucose.

The terms "spirit vinegar," "distilled vinegar," "grain 2 vinegar" shall be construed to mean the product made by 3 the acetous fermentations of dilute distilled alcohol.

Sect. 3. For the purpose of this act vinegar shall be 2 deemed to be adulterated:

First: If it contains any drugs, acids, coloring matter or 2 ingredients not derived exclusively from the substances 3 from which they were respectively made.

Second: If it contains less than four grams of acetic acid 2 in one hundred cubic centimeters of the vinegar at seventy 3 degrees Fahrenheit.

Third: If manufactured by the destructive distillation of

- 2 wood, known as pyroligneous acid, or acetic acid derived
- 3 from other sources than fruit, grain, vegetables, sugar or
- 4 syrup.

Fourth: If it is found to contain any preparation of lead,

- 2 copper, sulphur dioxide, sulphuric acid, other mineral acids
- 3 or any substitute for vinegar produced other than by alco-
- 4 holic and subsequent acetous fermentation or other ingre-
- 5 dients injurious to health.

Sect. 4. For the purpose of this act vinegar shall be

2 deemed to be misbranded:

First: If packages containing vinegar made from wine or

- 2 fruits which have been reduced with water are not plainly
- 3 marked or branded "Reduced to Four Per Centum Acid
- 4 Strength" or "Reduced to Forty Grains," indicating the
- 5 acidity to which it has been so reduced.

Second: If a product made from dried apples, or from

- 2 apple skins, apple cores and chops by the process of grind-
- 3 ing and soaking with subsequent alcoholic and acetous fer-
- 4 mentations of the solution thus obtained is not plainly
- 5 marked to show the material from which it is produced.

Third: If the package containing said vinegar or its label

- 2 is not plainly branded with the name of the manufacturer
- 3 and his place of business.

Fourth: If every container or receptacle which contains

- 2 any vinegar other than pure cider or apple vinegar, except
- 3 delivered to the purchaser in the unbroken package, does
- 4 not bear plain or conspicuous marks or brands, showing

5 the kind of vinegar so delivered and the substance or sub-6 stances from which it was made.

Fifth: If mixtures of two or more of the vinegars, above 2 defined, are not plainly and conspicuously branded with the 3 word "compound" together with the proportions of the 4 vinegars so mixed.

Sect. 5. Any person who adulterates or misbrands, with2 in the meaning of this act, any vinegar, or any person who
3 manufactures, sells, distributes, transports, offers or exposes
4 for sale, distribution or transportation any vinegar in vio5 lation of any of the provisions of this act shall be punished
6 by a fine not exceeding one hundred dollars for the first
7 offense, and by a fine not exceeding two hundred dollars
8 for each subsequent offense.
