STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Section Thirty-seven of Chapter One Hundred and Seventeen of the Revised Statutes of Nineteen Hundred and Sixteen, as Amended by Section One of Chapter One Hundred and Ninety-four of the Public Laws of Nineteen Hundred and Seventeen, as Further Amended by Chapter Two Hundred and Fourteen of the Public Laws of Nineteen Hundred and Nineteen, as Still Further Amended by Chapter Two Hundred and Nineteen of the Public Laws of Nineteen Hundred and Nineteen of the Public Laws of Nineteen Hundred and Twenty-one, Relative to the Salary of County Attorney of Lincoln County.

Be it enacted by the People of the State of Maine, as follows: Section thirty-seven of chapter one hundred and seven2 teen of the revised statutes of one thousand nine hundred 3 and sixteen, as amended by section one of chapter one hun-4 dred and ninety-four of the public laws of nineteen hun-5 dred and seventeen, as further amended by chapter two 6 hundred and fourteen of the public laws of nineteen hun-7 dred and nineteen, as still further amended by chapter two 8 hundred and nineteen of the public laws of nineteen hun-9 dred and twenty-one, is hereby amended by striking out 10 the words "five hundred dollars" in the eleventh line there-11 of and inserting the words 'seven hundred dollars,' so that 12 said section, as amended, shall read as follows:

'Sect. 37. Compensation of County Attorneys, 1915, c. 138. 2 County attorneys of the several counties shall receive an-3 nual salaries from the state treasury in monthly payments 4 on the last day of each month, as follows:

'Androscoggin, fifteen hundred dollars.

'Aroostook, fifteen hundred dollars.

'Cumberland, two thousand dollars.

'Franklin, five hundred dollars.

'Hancock, seven hundred and fifty dollars.

'Kennebec, fourteen hundred dollars.

'Knox, seven hundred dollars.

'Lincoln, seven hundred dollars.

'Oxford, nine hundred dollars.

'Penobscot, eighteen hundred dollars.

'Piscataquis, seven hundred dollars.

'Sagadahoc, seven hundred dollars.

- 'Somerset, eight hundred and fifty dollars.
- 'Waldo, five hundred dollars.
- 'Washington, nine hundred dollars.
- 'York, twelve hundred dollars;
- 'and no other fees, costs or remoluments shall be allowed
- 2 them. The assistant county attorney for the County of
- 3 Cumberland, twelve hundred dollars. He shall hold his of-
- 4 fice during the term of the county attorney by whom he
- 5 was appointed, subject to removal at any time by the jus-
- 6 tice of the superior court for said county.'
