STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Section Forty-four of Chapter Two Hundred and Seventeen, Revised Statutes, as Amended by Chapter One Hundred and Sixty-seven, Public Laws of Nineteen Hundred and Seventeen, Chapters Two Hundred and Fourteen, Two Hundred and Fifty-Nine and Two Hundred and Sixty, Public Laws of Nineteen Hundred and Nineteen and Chapter Two Hundred and Nineteen, Public Laws of Nineteen Hundred and Twenty-one, relating to Salary of County Treasurer of Lincoln County.

Be it enacted by the People of the State of Maine, as follows:
Section forty-four of chapter two hundred seventeen,
2 revised statutes as amended by chapter one hundred sixty3 seven, public laws of nineteen hundred seventeen, chapters
4 two hundred fourteen, two hundred fifty-nine and two hun-

5 dred sixty, public laws of nineteen hundred nineteen, and 6 chapter two hundred nineteen, public laws of nineteen hun-7 dred twenty-one, is hereby further amended by striking out 8 the words "three hundred dollars" in the twelfth line and 9 inserting in place thereof the words 'four hundred dollars,' 10 so that said section as amended shall read as follows:

'Sect. 44. County treasurers in the several counties shall 2 receive annual salaries from the treasuries of the counties 3 in monthly payments paid on the last day of each month, 4 as follows:

'Androscoggin, eighteen hundred dollars, 'Aroostook, eight hundred dollars, 'Cumberland, two thousand dollars, 'Franklin, four hundred dollars, 'Hancock, five hundred dollars, 'Kennebec, fifteen hundred dollars, 'Knox, four hundred dollars, 'Lincoln, four hundred dollars, 'Oxford, six hundred fifty dollars. 'Penobscot, eighteen hundred dollars, 'Piscataquis, five hundred dollars, 'Sagadahoc, five hundred dollars, 'Somerset, six hundred dollars, 'Waldo, four hundred dollars. 'Washington, seven hundred dollars, 'York, eight hundred fifty dollars.

'Each of the counties above named shall pay the premium on the official bond of its treasurer.'
