STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

RESOLVE, in Favor of Central Maine Sanatorium for Personal Services, Maintenance, Repairs and Equipment.

Resolved: That there be and hereby is appropriated for 2 the Central Maine Sanatorium:

PERSONAL SERVICES JUNE 30, 1923, TO JULY 1, 1925

For personal services, namely, for salaries and wages of

- 2 all officers and employees except those wholly engaged in
- 3 repairs of buildings and equipment, the sum of forty thou-
- 4 sand dollars for the period from July first, nineteen hundred
- 5 and twenty-three, to June thirtieth, nineteen hundred and
- 6 twenty-four; and the sum of forty thousand dollars from

7 July first, nineteen hundred and twenty-four, to June thir-8 tieth, nineteen hundred and twenty-five.

MAINTENANCE JULY 1, 1923, TO JUNE 30, 1925

For maintenance, namely, all articles of food and all other 2 materials, supplies and expenses incident to maintenance of 3 the institution and the patients thereof, whether present or 4 absent, the sum of ninety thousand dollars for the period 5 from July first, nineteen hundred and twenty-three, to June 6 thirtieth, nineteen hundred and twenty-four; and the sum 7 of ninety thousand dollars for the period from July first, 8 nineteen hundred and twenty-four, to June thirtieth, nine-9 teen hundred and twenty-five.

REPAIRS AND EQUIPMENT, JULY 1, 1923, TO JUNE 30, 1925

For repairs and equipment, including costs of all materials 2 and ordinary repairs, the sum of sixteen thousand dollars 3 for the period from July first, nineteen hundred and twenty-4 three, to June thirtieth, nineteen hundred and twenty-four; 5 and the sum of sixteen thousand for the period from July 6 first, nineteen hundred and twenty-four, to June thirtieth, 7 nineteen hundred and twenty-five.

STATEMENT OF FACTS

The appropriations called for by this Resolve are the same as recommended by the committee on budget for the years for which the above sums are appropriated.
