### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT Additional to Chapter Two Hundred Nineteen of the Public Laws of Nineteen Hundred Seventeen, as Amended, Fixing the Legal Length of, and Also Daily Limit on, Trout and Landlocked Salmon which May be Taken in Certain Rangeley Waters, in Franklin and Oxford Counties.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful for any person to take,

2 catch and kill, at any time, any trout less than ten inches in

3 length or any landlocked salmon less than fourteen inches in

4 length, in Rangeley lake, in the county of Franklin, or in

5 Cupsuptic lake, in the county of Oxford, or in Mooselucma
6 guntic lake, partly in the county of Oxford and partly in

7 the county of Franklin, or in Upper Richardson lake, or in 8 Lower Richardson lake, of the Rangeley chain of lakes, in 9 the county of Oxford, or in the portions of Kennebago and 10 Rangeley streams which are open to fishing.

It shall also be unlawful for any person to have in pos-2 session at any time any trout less than ten inches in length 3 or any landlocked salmon less than fourteen inches in length 4 taken in any of the above named waters.

Sect. 2. It shall also be unlawful for any person to take, 2 catch and kill in any one day more than ten pounds of land-3 locked salmon and trout in all in any of the above named 4 lakes.

It shall also be unlawful for any person to have in pos-2 session at any time more than ten pounds of trout and land-3 locked salmon in all, taken in any one day in any of the 4 above named lakes; except the taking, catching and killing, 5 or having in one's possession one trout or salmon weighing 6 more than ten pounds, or two such fish, each weighing less 7 than ten pounds, shall not be considered a violation of this 8 act.

Sect. 3. Whoever violates any provision of this act shall 2 pay a fine of not less than ten nor more than thirty dollars 3 and costs for each offense, and one dollar additional for 4 each fish taken, caught, killed or had in possession in vio-5 lation hereof.
