IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

---

AN ACT to Amend Chapter One Hundred and Ninety-seven of the Public Laws of 1917 as Amended by Chapter One Hundred and Seventy-two of the Public Laws of 1919 as Amended by Chapter One Hundred and Sixty-two of the Public Laws of 1921, and to Amend Chapter Nineteen of the Revised Statutes as Amended, Relating to the State Department of Health.

---

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section eight of chapter one hundred and  
2 ninety-seven of the public laws of nineteen hundred and  
3 seventeen, as amended by chapter one hundred and seventy-  
4 two of the public laws of nineteen hundred and nineteen,

5 as amended by chapter one hundred and sixty-two of the  
6 public laws of nineteen hundred and twenty-one, is hereby  
7 further amended by striking out the word "forty-six" in  
8 the second line thereof, and substituting therefor the word  
9 'fifty-one,' so that the said section eight, as amended, shall  
10 read as follows:

'Sect. 8. The sum of fifty-one thousand dollars shall be  
2 annually appropriated for the purposes set forth in sections  
3 one to six inclusive and section seven of this act.'

Sect. 2. Section two of chapter one hundred and seventy-  
2 two of the public laws of nineteen hundred and nineteen,  
3 enacting section sixteen as an additional section to chapter  
4 one hundred and ninety-seven of the public laws of nine-  
5 teen hundred and seventeen, as amended by chapter one  
6 hundred and sixty-two of the public laws of nineteen hun-  
7 dred and twenty-one is hereby amended by striking out the  
8 word "thirty-five" in the first line of said section sixteen  
9 and substituting therefor the word 'forty-six,' omitting the  
10 word "and" in the third line between the words twelve and  
11 thirteen, and adding after the word thirteen in the third  
12 line the words 'and fourteen,' so that said section sixteen,  
13 as amended, shall read as follows:

'Sect. 16. The sum of forty-six thousand dollars shall be  
2 appropriated annually to the state department of health for  
3 the purpose of carrying out the provisions of sections six,  
4 ten, eleven, twelve, thirteen and fourteen.'

Sect. 3. Chapter nineteen of the revised statutes as

2 amended by chapter three hundred and one of the public  
3 laws of nineteen hundred and seventeen, and as further  
4 amended by chapter one hundred and seventy-two of the  
5 public laws of nineteen hundred and nineteen, as further  
6 amended by chapter one hundred and sixty-two of the  
7 public laws of nineteen hundred and twenty-one, is further  
8 amended by striking out the word "ten" in the third line  
9 of section one hundred and thirty-one, and substituting  
10 therefor the word 'seventeen,' so that said section one  
11 hundred and thirty-one, as amended, shall read as follows:

'Sect. 131. For the purpose of enabling the state board of  
2 health to carry out the provisions of this act there is hereby  
3 appropriated the sum of seventeen thousand dollars.'
