STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

RESOLVE, in Favor of the Reformatory for Women for Maintenance and Other Purposes.

Resolved: That there be and hereby is appropriated the 2 sum of fifteen thousand dollars, five hundred dollars for 3 the year from July first, nineteen hundred twenty-three to 4 June thirtieth, nineteen hundred twenty-four, and fifteen 5 thousand, five hundred dollars for the year from July first, 6 nineteen hundred twenty-four to June thirtieth, nineteen 7 hundred twenty-five, for personal services, namely, salaries 8 and wages of all officers and employees, except those wholly 9 engaged in repairs of buildings and equipment of the state 10 reformatory for women.

The sum of twenty-five thousand dollars for the year from 2 July first, nineteen hundred twenty-three to June thirtieth, 3 nineteen hundred twenty-four, and the sum of thirty thou-4 sand dollars for the year from July first, nineteen hundred 5 twenty-four to June thirtieth, nineteen hundred twenty-five, 6 for maintenance, including food supplies, clothing, replace-7 ments and for general expenses of the state reformatory for 8 women.

The sum of twelve thousand dollars for the year from 2 July first, nineteen hundred twenty-three to June thirtieth, 3 nineteen hundred twenty-four, and ten thousand dollars for 4 the year from July first, nineteen hundred twenty-four to 5 June thirtieth, nineteen hundred twenty-five, for repairs 6 and equipment of the state reformatory for women.

The sum of twenty thousand dollars for the year from 2 July first, nineteen hundred twenty-three to June thirtieth, 3 nineteen hundred twenty-four, for new construction and 4 permanent improvements, meaning an additional story to 5 Stevens cottage.

Making a total of one hundred twenty-eight thousand 2 dollars, for the two fiscal years aforesaid.

STATEMENT OF FACTS

All of the above amounts, are the amounts recommended in the report of the budget committee.
