STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

RESOLVE, in Favor of Northern Maine Sanatorium, at Presque Isle, Aroostook County, for Personal Services, Maintenance, Repairs and Improvements.

Resolved: That there be and hereby is appropriated for 2 the Northern Maine Sanatorium:

For personal services, namely, salaries and wages of all 2 officers and employees, except those wholly engaged in re-3 pairs, and construction of buildings and equipment, for the 4 period from July first, nineteen hundred twenty-three, to 5 June thirtieth, nineteen hundred twenty-four, the sum of 6 twenty-two thousand dollars; for the period from July first, 7 nineteen hundred twenty-four, to June thirtieth, nineteen

8 hundred twenty-five, the sum of twenty-two thousand dol-9 lars.

For maintenance, namely, all articles of food and all other 2 materials, supplies and expenses incident to maintenance of 3 the institution and for the patients thereof, whether present 4 or absent, for the period from July first, nineteen hundred 5 twenty-three, to June thirtieth, nineteen hundred twenty-6 four, the sum of forty-six thousand dollars; for the period 7 from July first, nineteen hundred twenty-four, to June thir-8 tieth, nineteen hundred twenty-five, the sum of forty-six 9 thousand dollars.

For repairs and improvements, for the period from July 2 first, nineteen hundred twenty-three, to June thirtieth, nine-3 teen hundred twenty-four, the sum of three thousand dol-4 lars; for the period from July first, nineteen hundred twen-5 ty-four, to June thirtieth, nineteen hundred twenty-five, the 6 sum of three thousand dollars.

For finishing basement, adding X-ray machine, sterilizer, 2 high pressure boiler, and quarters for the help in the new 3 building, the sum of ten thousand dollars for the year of 4 nineteen hundred twenty-four.

Unexpended balance continued. Provided that the bal-2 ance of any sums above appropriated, which may remain 3 unexpended at the end of the fiscal period for which ap-4 propriated, may be available for expenditure for improve-5 ments and repairs during the succeeding fiscal period, if 6 so ordered by the governor and council, and provided, fur7 ther, that the governor and council may, by order, upon 8 recommendation of the trustees of said institution, authorize 9 the transfer of the unexpended balance of any of the above 10 appropriations to any other appropriation for said insti-11 tution.

STATEMENT OF FACTS

The absolute need of an X-ray machine and high pressure boiler with sterilizer and the finishing of the basement in one wing of the institution, together with the fact that both buildings must be painted, make it necessary that the institution be given the amount originally asked for at the hearing before the budget committee.
