# STATE OF MAINE

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT Amending Section Thirty-three and Chapter One Hundred Twenty-seven of the Revised Statutes of Maine, Relating to the Disposal of Intoxicating Liquors Declared Forfeited.

Be it enacted by the People of the State of Maine, as follows:
Section thirty-three of chapter one hundred twenty-seven
2 of the revised statutes of Maine is hereby amended by
3 striking out the whole of said section and inserting in place
4 thereof the following section, so that said section, as amend5 ed, shall read as follows:

'Sect. 33. All spirituous and distilled liquors and all other 2 liquors, declared forfeited by any court under this chapter,

3 which shall have been found by said court to contain more 4 than twenty per cent of alcohol, shall, by order of the court 5 rendering final judgment thereon, be turned over to the 6 sheriff of the county where such seizure was made, by any 7 officer competent to serve the process on which they were 8 forfeited, and he shall make return accordingly to said 9 court; and said sheriff shall receipt to said officer there-10 for; said sheriff shall mingle said liquors together, and as II soon as he has accumulated a quantity equal to five barrels, 12 he shall ship the same to some responsible rectifying dis-13 tiller, outside of this state, and have the alcohol redistilled 14 therefrom, as is hereinafter provided. Said sheriffs shall 15 annually contract with some responsible rectifying distiller, 16 outside the limits of this state to take such liquors and distill 17 the alcohol therefrom, and to account for and pay over to 18 the treasurer of the county from which said liquors are re-19 ceived, in cash, at an agreed price for each gallon of one 20 hundred degrees strength, determined by the United States 21 internal revenue inspector at place of rectification. Before 22 delivering any liquor under the aforesaid contract, the said 23 sheriff shall take a bond, with sureties residing in this 24 state, and to be approved by the treasurer of the county, 25 from said rectifying distiller to the treasurer of his county, 26 in the penal sum of one thousand dollars, conditioned that 27 all of said liquors so received under said contract, shall be 28 rectified and the alcohol distilled therefrom, and that the 29 contractor will account for and pay over to the treasurer

30 of said county from which said liquors are received, in cash, 31 the amount due under said contract. In all suits upon 32 bonds given under this section the damages shall be the full 33 penal sum of said bond. All other liquors, except cider, 34 declared forfeited by any court under this chapter, shall, 35 by order of the court rendering final judgment thereon, be 36 destroyed by any officer competent to serve the process on 37 which they were forfeited, and he shall make return ac-38 cordingly to said court. Such liquors shall be destroyed by 39 pouring them upon the ground. A record of vessels for-40 feited shall be kept by each officer, and returned to the 41 county commissioners once in each three months, and once 42 in six months, or oftener, if they deem it advisable the 43 commissioners shall order such officers to sell the vessels at 44 public or private sale, and pay the proceeds thereof into the 45 county treasury.

All cider, declared forfeited by any court under this chap-2 ter, shall by order of the court rendering final judgment 3 thereon, be turned over to the sheriff of the county where 4 such seizure was made, by any officer competent to serve 5 the process on which they were forfeited, and he shall make 6 return according to said court; and said sheriff shall receipt 7 to said officer therefor. Said sheriffs may sell and dispose 8 of such cider to be used in the manufacture of vinegar and 9 for no other purpose. A record of such sales shall be kept 10 by each sheriff and he shall pay the proceeds from such 11 sales into the county treasury. Before delivering any cider

12 under any sale made in accordance with the provisions of 13 this section, the said sheriff shall take a bond, with sureties 14 residing in this state, and to be approved by the treasurer 15 of the county, from the purchaser of such cider in the 16 penal sum of double the amount of the value of such cider, 17 conditioned that all of said cider so received under such 18 sale, shall be used in the manufacture of vinegar and for 19 no other purpose.'
