RESOLVE, in Favor of the Bangor State Hospital for Maintenance and Other Purposes for the Years July First Nineteen Hundred Twenty-three to June Thirtieth Nineteen Hundred Twenty-four, and July First Nineteen Hundred Twenty-four to June Thirtieth Nineteen Hundred Twenty-five.

Resolved: That there be, and hereby is, appropriated for

For personal services, namely, for salaries and wages of all officers and employees except those wholly engaged in repairs of buildings and equipment for the year July first nineteen hundred twenty-three to June thirtieth nineteen hundred twenty-four, the sum of one hundred five thousand seven hundred nineteen dollars, and for the year July first nineteen hundred twenty-four to June thirtieth nineteen hundred twenty-five, the sum of one hundred five thousand seven hundred nineteen dollars. \$105,719.00 \$105,719.00

For maintenance, namely, all articles of food, wearing apparel, heat, light and power, farm and industrial activities, other institutional expenses, and parole or community services, for the year July first nineteen hundred twenty-three to June thirtieth nineteen hundred twenty-four, the sum of one hundred thirty-six thousand eight hundred twenty-five, and for the year July first nineteen hundred twenty-

four to June thirtieth nineteen hundred twenty-five, the sum of one hundred thirty-six thousand eight hundred twenty-five dollars.

For repairs and equipment, namely, all labor, materials and supplies required for upkeep of automobiles, buildings and grounds, household furniture and fixtures, office furniture, surgical instruments, machinery and tools, pipe and fittings, insurance, farm equipment and livestock, and all other proper charges, for the year July first nineteen hundred twenty-three, to June thirtieth nineteen hundred twenty-four, the sum of fifty-three thousand seven hundred forty dollars, and for the year July first nineteen hundred twenty-four to June thirtieth nineteen hundred twenty-five the sum of forty-four thousand nine hundred forty dollars.
