**IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-THREE**

RESOLVE, for Charitable and Benevolent Institutions, for  
the Care, Support and Medical or Surgical Treatment of  
Certain Persons.

---

Resolved: That there be appropriated for the fiscal year  
2 from July first, nineteen hundred twenty-three to June  
3 thirtieth, nineteen hundred twenty-four, the sum of one  
4 hundred eighty-seven thousand four hundred fifty dollars,  
5 and for the fiscal year from July first, nineteen hundred  
6 twenty-four to June thirtieth, nineteen hundred twenty-five,  
7 the sum of one hundred eighty-seven thousand four hun-  
8 dred fifty dollars, for the necessary care and medical or  
9 surgical treatment, at the rates specified and in, or by, the

10 institutions and organizations named, of certain classes of  
 11 persons whose own resources, or the resources of whose  
 12 responsible relatives as defined by section eighteen of chap-  
 13 ter twenty-nine of the revised statutes, are insufficient to  
 14 pay for the same, and for other purposes, namely:

For the care and support of children under sixteen years  
 2 of age including those supported away from their parents  
 3 under the provisions of sections fifty-one to fifty-five in-  
 4 clusive, chapter sixty-four, revised statutes, and acts amend-  
 5 atory thereof, at not to exceed three dollars and fifty cents  
 6 per week, including direct payments from sources other  
 7 than the state:
