IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-THREE

---

AN ACT to Amend Chapter One Hundred and Ninety-seven  
of the Public Laws of 1917, as Amended by Chapter One  
Hundred and Seventy-two of the Public Laws of 1919 as  
Amended by Chapter One Hundred and Sixty-two of the  
Public Laws of 1921, and to Amend Chapter Nineteen of  
the Revised Statutes as Amended, Relating to the State  
Department of Health.

---

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section eight of chapter one hundred ninety-  
2 seven of the public laws of nineteen hundred seventeen, as  
3 amended by chapter one hundred seventy-two of the public  
4 laws of nineteen hundred nineteen, as amended by chapter

5 one hundred sixty-two of the public laws of nineteen hun-  
6 dred twenty-one, is hereby further amended by striking  
7 out the word "forty-six" in the second line thereof and  
8 substituting therefor the word 'fifty-three,' so that said  
9 section eight as amended shall read as follows:

'Sect. 8. The sum of fifty-three thousand dollars shall be  
2 annually appropriated for the purposes set forth in sections  
3 one to six inclusive and section seven of this act.'

Sect. 2. Section two of chapter one hundred seventy-two  
2 of the public laws of nineteen hundred nineteen, enacting  
3 section sixteen as an additional section to chapter one hun-  
4 dred ninety-seven of the public laws of nineteen hundred  
5 and seventeen, as amended by chapter one hundred sixty-  
6 two of the public laws of nineteen hundred and twenty-one  
7 is hereby amended by striking out the word "thirty-five"  
8 in the first line of said section sixteen and substituting  
9 therefor the word 'thirty-eight'; omitting the word "and"  
10 in the third line between the words "twelve and thirteen"  
11 and adding after the word "thirteen" in the third line the  
12 words 'and fourteen,' so that said section sixteen as amend-  
13 ed shall read as follows:

'Sect. 16. The sum of thirty-eight thousand dollars shall  
2 be appropriated annually to the state department of health  
3 for the purpose of carrying out the provisions of sections  
4 six, ten, eleven, twelve, thirteen and fourteen.'

Sect. 3. Chapter nineteen of the revised statutes as  
2 amended by chapter three hundred one of the public laws

3 of nineteen hundred seventeen, and as further amended by  
4 chapter one hundred seventy-two of the public laws of  
5 nineteen hundred nineteen, as further amended by chapter  
6 one hundred sixty-two of the public laws of nineteen hun-  
7 dred twenty-one, is further amended by striking out the  
8 word "ten" in the third line of section one hundred thirty-  
9 one and substituting therefor the word 'fourteen,' so that  
10 said section one hundred thirty-one, as amended, shall read  
11 as follows:

'Sect. 131. For the purpose of enabling the state board  
2 of health to carry out the provisions of this act there is  
3 hereby appropriated the sum of fourteen thousand dollars.'
