STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT Relating to the Trapping of Fur-bearing Animals.

Be it enacted by the People of the State of Maine, as follows:

Section fifty of chapter thirty-three of the revised stat-

- 2 utes, as amended by chapters two hundred and nineteen
- 3 and two hundred and forty-four of the public laws of nine-
- 4 teen hundred and seventeen, and by chapter one hundred
- 5 and ninety-six of the public laws of nineteen hundred and
- 6 nineteen, is hereby amended by striking out all of said sec-
- 7 tion and by substituting therefor the following section:

'Sect. 50. Whoever hunts, captures or traps any fur-bear-

- 2 ing animal or animals, except bobcats, loupcervier, Canada
- 3 lynx or bears, anywhere in the state, shall annually procure
- 4 a license therefor from the commissioner of inland fish-

5 eries and game, paying therefor a fee of ten dollars for 6 such hunting or trapping in the unorganized townships of 7 the state, and five dollars for such hunting or trapping 8 within the limits of the cities, towns and plantations in the o state; provided, further, that whoever hunts, captures or 10 traps any beaver in any territory anywhere in the state 11 opened to beaver trapping by said commissioner shall pay 12 therefor a fee of twenty-five dollars annually. The pro-13 visions of this section shall not be construed as applying 14 to minors under sixteen years of age who desire to hunt 15 or trap fur-bearing animals except beaver (for which a 16 twenty-five dollar trapping license is required) in any of 17 the organized townships of the state, nor as affecting the 18 right of a bona fide resident of this state, or his immediate 10 family, to hunt or trap fur-bearing animals (except beaver) 20 in accordance with the laws of the state, without such trap-21 ping license, on land owned by him or on land leased by 22 him and on which he is actually domiciled, within the limits 23 of an organized township, and which land is used exclu-24 sively for agricultural purposes.'

'Each person licensed under the provisions of this section 2 shall, on or before the thirty-first day of December of each 3 year, make such report to said commissioner as may be 4 called for by him.

'Whoever hunts, captures or traps any fur-bearing animal, 2 or animals, except bobcats, Canada lynx, or bears, anywhere 3 in the state, in violation of any provision of this section

4 shall pay a fine of not less than ten dollars nor more than 5 one hundred dollars and costs for each offense. Whoever 6 has in possession at any time any fur-bearing animal, or 7 part or parts thereof, except bobcats, loupcervier, Canada 8 lynx, or bears, taken in violation of any provision of this 9 section, shall be subject to the same penalty.

'Provided, however, that whoever hunts, captures or traps 2 any beaver anywhere in the state, in violation of any pro-3 vision of this section shall pay a fine of one hundred dol-4 lars and costs for each offense. Whoever has in possession 5 any beaver at any time, or part or parts thereof, taken in 6 violation of any provision of this section, shall be subject 7 to the same penalty.'
