### STATE OF MAINE

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Section Thirty-five, Chapter Forty-five of the Revised Statutes, Relating to Legal Size of Lobsters and Method of Measurement.

Be it enacted by the People of the State of Maine, as follows: Section thirty-five of chapter forty-five of the revised
2 statutes is hereby amended by striking out the whole of
3 said section and enacting in place thereof the following: 'Sect. 35. No person within the counties of Androscoggin,
2 Aroostook, Franklin, Hancock, Kennebec, Knox, Lincoln,

3 Oxford, Penobscot, Piscataquis, Sagadahoc, Somerset,4 Waldo, or Washington, shall buy or sell, give away or ex-

5 pose for sale, or possess for any purpose, any lobster, alive

6 or dead, cooked or uncooked, less than four and three-7 fourths inches in length, measured on the back from the 8 end of the bone of the nose to the center of the rear end 9 of the body shell; and no person within the counties of 10 Cumberland and York shall buy or sell, give away or expose II for sale, or possess for any purpose, any lobster, alive or 12 dead, cooked or uncooked, less than three inches in length, 13 measured on the back from the innermost edge of the eye-14 socket to the nearest point of the rear end of the body 15 shell; and every lobster shorter than four and three-fourths 16 inches, caught in the counties of Androscoggin, Aroostook, 17 Franklin, Hancock, Kennebec, Knox, Lincoln, Oxford, 18 Penobscot, Piscataquis, Sagadahoc, Somerset, Waldo or 19 Washington, measured according to the method herein pre-20 scribed for said counties, and every lobster shorter than 21 three inches, caught in the counties of Cumberland and 22 York, measured according to the method herein prescribed 23 for said counties, shall be immediately liberated alive at the 24 risk and cost of the parties taking it, under penalty of five 25 dollars for each lobster so caught, bought, sold, given away, 26 exposed for sale, or in possession. The possession of muti-27 lated lobsters, cooked or uncooked, shall be prima facie 28 evidence that they are not of the required length. All lob-29 sters, or parts of lobsters, sold for use in this state or 30 delivered for export therefrom, must be sold or delivered 31 in the shell, under a penalty of fifty dollars for each offence; 32 and whoever ships, transports, carries, buys, gives away, 33 sells, or exposes for sale, lobster meat, after the same shall 34 have been taken from the shell, shall be liable to a penalty 35 of five dollars for each pound of meat so shipped, trans-36 ported, carried, bought, given away, sold, or exposed for 37 sale. Any person or corporation engaged in the business of 38 common carrier, who shall knowingly carry or transport 39 from place to place lobster meat, after the same shall have 40 been taken from the shell, shall, upon conviction, be fined 41 fifty dollars for each offence. In case of seizure, by a duly 42 authorized officer, all meat so illegally shipped, transported, 43 carried, bought, given away, sold or exposed for sale shall 44 be forfeited and disposed of under the provisions of section 45 forty-seven. Nothing contained herein shall be held to pro-46 hibit the sale of lobsters that have been legally canned.'
