STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Incorporate the Bay Point Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The territory embraced within the following

- 2 limits, to wit: all that portion of Bay Point, so-called, in the
- 3 town of Georgetown, which is bounded and described as
- 4 follows, to wit: Beginning at a point where the northerly
- 5 line of the Bay Point Road, so-called, intersects the westerly
- 6 line of the Kennebec Point Road, so-called; thence running
- 7 southerly by said westerly line of said Kennebec Point Road
- 8 and by the continuation of said line, to the Atlantic Ocean
- 9 at low water mark; thence following the shore southerly,
- 10 westerly and northerly by low water mark of said Atlantic
- 11 Ocean and of the Kennebec River, to the southwesterly

12 corner of land of the heirs of John Warren; thence east13 erly in a straight line by the southerly line of the land of
14 said John Warren heirs, by land of the heirs of Elijah Spin15 ney, and by land of the Sinclair heirs, to the point of be16 ginning; together with the inhabitants thereon and certain
17 owners of real estate thereon, as hereinafter specified, is
18 hereby created a body politics and corporate, by the name
19 of the Bay Point Village Corporation.

Sect. 2. Said corporation is hereby authorized and vested 2 with the power at any legal meeting called for the purpose 3 to raise money for the following purposes: To create and 4 maintain a fire department with all the necessary equip-5 ment, appliances and apparatus for the prevention and ex-6 tinguishment of fires; to build, repair and maintain roads, 7 streets and ways, sidewalks, sewers and other sanitary works, 8 including the collection and removal of offal and garbage; 9 to care for and beautify that portion of said territory which To has been or may hereafter be reserved for and dedicated II to public uses to be enjoyed in common by all the owners 12 of estates in said territory and to that end to build roads 13 and walks upon and through said public lands and to plant 14 and care for trees in the roads and streets and upon said 15 public lands; to build, repair and maintain public wharves 16 and landings; to establish and maintain police and night 17 watch; to procure water for fire, domestic and other pur-18 poses and to produce or procure light for public use and 19 for the use of the inhabitants of said territory, and for such

20 purposes to contract with any individual, firm or corpora-21 tion to furnish such water or light for either or both of 22 the purposes named and to establish reasonable rates sub-23 ject to approval by the public utilities commission, to be 24 paid by the inhabitants of said territory using such water 25 or light for domestic purposes; to construct, maintain and 26 operate telephone and telegraph lines or to aid in such con-27 struction, maintenance and operation and to that end and 28 for that purpose to contract with any corporation, firm or 29 individual therefor; and to defray any and all other neces-30 sary or proper corporate charges.

Sect. 3.—The town of Georgetown is hereby relieved from 2 any and all duty to build, repair or maintain roads, streets 3 or ways upon said territory or to build school houses or 4 to maintain schools thereon, except that any school children 5 residing within the corporate limits of the Village corpora-6 tion shall have the right to attend school in the town of 7 Georgetown, or to perform any of the duties for which 8 said corporation is authorized by section two of this act 9 to raise money, and said town shall not be liable for defects 10 in streets, ways or roads in said territory nor for failure II to perform any duty from which it is relieved by this act, 12 but said corporation shall assume all of said duties and be 13 liable for said defects in streets, ways and roads and for 14 failure to perform the duties assumed as the town of George-15 town would have been liable except for this act, which lia-16 bility may be enforced under the same condition, in the

17 same manner and with the same remedies as are provided 18 by law in relation to towns.

- Sect. 4. Said corporation and the overseers thereof shall 2 have the same power and duties in laying out, discontinuing 3 and altering town ways in said territory which the town of 4 Georgetown and the selectmen now have, to be exercised 5 and performed under the same conditions and limitations 6 and in the same manner that they are now exercised and 7 performed by said town and its selectmen.
- Sect. 5. The town of Georgetown shall annually pay over 2 to the treasurer of said corporation out of the taxes col-3 lected from the inhabitants and estates in said territory a 4 sum equal to sixty per centum of all the town taxes, exclusive of the state and county tax, collected from said inhabitants and estates.
- Sect. 6. All moneys which shall be raised for the purposes 2 named in section two of this act or for any other purpose, 3 for which the corporation may lawfully raise money, shall 4 be assessed upon the taxable polls and estates embraced 5 within the limits of the corporation by the assessors of the 6 town of Georgetown in the same manner as is provided by 7 law for the assessment of town and county taxes. For the 8 purposes of taxation under the act the person or persons 9 entitled to the use or occupation of any lot of land in said 10 territory shall be deemed the owner thereof and be taxed for 11 said lot and the improvements, if any, thereon.
- Sect. 7. The officers of said corporation shall be a clerk, 2 who shall be a resident of this state, a treasurer and five

3 overseers, who shall be chosen by ballot, and such other 4 officers as the by-laws of said corporation may require. 5 Said corporation is empowered to adopt at any legal meet-6 ing called for that purpose a code of by-laws for the proper 7 management of its prudential affairs and other purposes 8 connected therewith, provided said by-laws are not repugnant 9 to the laws of the State. Such code of by-laws may be 10 altered or amended at any legal meeting of the corporation 11 in the call for which notice of the proposed change has been 12 given. The officers aforesaid shall be sworn before the 13 clerk or justice of the peace and the treasurer shall give 14 bond to said corporation in such sum as the overseers may 15 direct, which bond shall be approved by the overseers and 16 clerk.

Sect. 8. Any person who is a legal voter in said corpora-2 tion may be elected or appointed to any office therein, but 3 shall cease to hold said office whenever he ceases to be such 4 legal voter.

Sect. 9. Said overseers shall be the general municipal 2 officers of said corporation and shall have general charge of 3 its affairs and of the expenditure of all money therein ex-4 cept so far as the same may be committed to other officers 5 or persons.

Sect. 10. Upon a certificate being filed with the assessors 2 of the town of Georgetown by the clerk of this corporation 3 of the amount of money voted to be raised at any meeting 4 for any of the purposes aforesaid, it shall be the duty of 5 said assessors or their successors in office, at the time of

6 the next annual assessment of town and county taxes in 7 said town of Georgetown to assess the total amounts certi-8 fied by the clerk of this corporation upon the polls and es-9 tates of persons residing within the limits of said corpora-10 tion and upon the estates of non-resident proprietors there-II of and to certify and deliver the lists of the assessments so 12 made to the collector of the town of Georgetown, whose 13 duty it shall be to collect the same in like manner as county 14 and town taxes are by law collected and said collector shall 15 pay over all moneys collected by him to the treasurer of said 16 corporation whenever the overseers shall so direct. It shall 17 be the duty of the treasurer of said corporation to receive 18 all moneys belonging to the corporation and to pay it out 19 only upon the written order or direction of the overseers 20 and to keep a regular account of all moneys received and 21 paid out and to exhibit the same to the overseers whenever 22 requested, and said town of Georgetown shall have the 23 same power to direct the mode of collecting said assess-24 ments it has in the collection of the town taxes and said 25 collector shall have the same rights and powers to recover 26 any taxes committed to him under the provisions of this 27 act by suit that he has for the collection of town taxes 28 committed to him and the town of Georgetown shall have 29 the same right to recover taxes assessed under this act by 30 suit that it has to recover town taxes assessed therein. 31 collector of Georgetown shall be entitled to receive the same 32 percentage for the collection of taxes assessed under this 33 act and the same fees in connection with the collection 34 thereof which he receives for the collection of the town 35 taxes.

Sect. 11. All persons residing within the limits of said 2 corporation, who would be legal voters in the town of 3 Georgetown and every person of lawful age who owns and 4 is in possession of one or more lots of land in said territory 5 shall be legal voters at any meeting of said corporation at 6 which they are present. The overseers of said corporation 7 shall determine who are the legal voters at any meeting and 8 shall prepare a list of said voters at least twenty-four hours 9 before every meeting, which said list they may amend or 10 correct at any time before said meeting or during its prog-The vote upon any proposition at any meeting shall 12 be taken and checked by this list upon the demand of five 13 legal voters; provided, however, that every person, who by 14 virtue of a joint ownership of himself and some other per-15 son or persons, and by agreement with the other joint own-16 ers, is in possession of a certain aliquot part of a lot of land 17 in said territory upon which he has a dwelling house owned 18 and controlled by himself exclusively, shall be deemed a 19 legal voter at any meeting of the corporation at which he 20 is present.

Sect. 12. The first election of officers shall be at the 2 meeting at which this charter is accepted. Said officers 3 shall hold their respective offices until the next annual meet-4 ing of the corporation, at which said meeting officers shall

5 be elected and thereafterwards at each annual meeting, but 6 in any event all officers duly elected shall hold office until 7 their successors are elected and duly qualified. The annual 8 meeting of said corporation shall be held on the last Saturgay of July in each year.

Sect. 13. This charter may be accepted at any time with-2 in two years from its approval by the governor, but only 3 one meeting to vote thereon shall be called in any one 4 calendar year. Harry W. Corsman, Carroll A. Deering, 5 William O. Oliver, Augustus Perrow, Laura M. Morse, 6 Frank A. Norton, Ruth H. Farnham and Charles F. Johan-7 son, or either of them, may call all meetings of the corpora-8 tion previous to the acceptance of the charter and the elec-9 tion of officers, and notify the persons entitled to vote 10 therein to meet at some suitable time and place, in said 11 territory, by posting of notices in two public places in said 12 territory seven days at least before the time of holding said 13 meeting; all subsequent meetings shall be called and notified 14 by the overseers as town meetings shall be called and noti-15 fied by the selectmen; either of the above named persons 16 are authorized to preside at any meeting previous to the 17 acceptance of the charter until the meeting is organized 18 and until a moderator shall have been chosen by ballot 10 and sworn; at all meetings of the corporation a moderator 20 shall be chosen in the manner and with the same power as 21 in town meetings.

Sect. 14. This act shall take effect when approved by the

- 2 Governor so far as to authorize the calling of a meeting or
- 3 meetings of said corporation for the purpose of voting upon
- 4 the acceptance of this charter, and whenever this charter
- 5 shall be accepted by a majority of the voters of said cor-
- 6 poration at a legal meeting called for that purpose, then
- 7 the same shall take and have complete effect in all its parts.
