STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

AN ACT to Amend the Charter of the Dover and Foxcroft
Water District.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section six of chapter fifty-four of the private
2 and special laws of nineteen hundred and five as amended
3 by section two of chapter two hundred and eighty-five of the
4 private and special laws of nineteen hundred and eleven
5 as amended by chapter fourteen of the private and special
6 laws of nineteen hundred and twenty-three, is further
7 amended by striking out the words "one hundred and
8 seventy-five" in the third line thereof and inserting in lieu
9 thereof the words, 'two hundred and fifty,' and by insert-
10 ing after the word "expedient," in the fifth line thereof,
11 the words, 'subject to the provisions of chapter fifty-five,

12 sections thirty-seven to thirty-nine, both inclusive, of the
13 revised statutes of Maine, and all acts amendatory thereof
14 and additional thereto,' so that said section as amended shall
15 read as follows:

'Sect. 6. Said Dover and Foxcroft Water District is au-
2 thorized to issue its bonds in amounts not exceeding in the
3 aggregate two hundred and fifty thousand dollars outstand-
4 ing at one time, for such purposes, and on such terms and
5 conditions as it may deem expedient, subject to the pro-
6 visions of chapter fifty-five, sections thirty-seven to thirty-
7 nine, both inclusive, of the revised statutes of Maine, and
8 all acts amendatory thereof and additional thereto. Said
9 bonds shall have interest coupons attached. Said bonds
10 shall be signed in behalf of said corporation by its treas-
11 urer and countersigned by its assessors, and the coupons
12 attached thereto shall be impressed by the fac-simile of the
13 signature of its treasurer. Said bonds shall be a legal ob-
14 ligation of said water district, which is hereby declared to
15 be a quasi-municipal corporation within the meaning of
16 section fifty-five, chapter forty-six, of the revised statutes
17 and all the provisions of said section shall be made appli-
18 cable thereto. Said bonds, it is hereby declared, shall be
19 public funds of the state of Maine, within the meaning of
20 section one of chapter one hundred and sixty-one of the
21 public laws of one thousand eight hundred and ninety-five.'

Sect. 2. Nothing herein contained is intended to repeal
2 or shall be construed as repealing the whole or any part

3 of any existing statute. And all the rights and duties here-
4 in mentioned shall be exercised and performed in accord-
5 ance with all the applicable provisions of chapter fifty-five
6 of the revised statutes.
