STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

AN ACT Relating to Fishing in Certain Waters in Franklin
and Oxford Counties.

Be it enacted by the People of the State of Maine, as follows:

Section five of chapter one hundred and eighty-six of the
2 public laws of nineteen hundred and twenty-three is hereby
3 amended by striking out the words "provided, however,
4 that in said Pond-in-the-River it shall also be lawful to fish
5 by trolling, so-called, from the time the ice goes out of said
6 Pond-in-the-River in the spring until July first following
7 of each year, both days inclusive; provided further," in the
8 tenth, eleventh, twelfth, and thirteenth lines thereof, and
9 inserting in place thereof the word 'provided,' so that said
10 section, as amended, shall read as follows:

'It shall be unlawful for any person to fish for, take, catch
2 or kill, any kind of fish at any time, in the pool at Upper
3 Dam, so-called, between Mooselucmeguntic and Upper
4 Richardson lake, or in the river leading from said pool to
5 Upper Richardson lake, or in Rapid river between Lower
6 Richardson and Umbagog lakes, or in Pond-in-the-River,
7 so-called, in said Rapid river, in the county of Oxford, ex-
8 cept it shall be lawful to fish in said waters in the ordi-
9 nary way of casting with artificial flies or fly fishing, so-
10 called, from the time the ice is out of said waters in the
11 spring until the thirtieth day of September following of
12 each year, both days inclusive; provided, it shall be un-
13 lawful for any person to catch and kill more than one fish
14 in any one day in said pool at Upper Dam, or in the river
15 leading from said pool to Upper Richardson lake, or in
16 said Rapid river, or in said Pond-in-theRiver, from Sep-
17 tember fifteenth to September thirtieth of each year, both
18 days inclusive.'
