STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Chapter One Hundred Ninety-five of the Private and Special Laws of Eighteen Hundred Eightyseven, Entitled "An Act to Amend an Act Incorporating the City of Waterville," as Amended by Chapter Sixteen of the Private and Special Laws of Nineteen Hundred Seventeen.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L. 1887, c. 195, Amended. Chapter one hundred

- 2 and ninety-five of the private and special laws of eighteen
- 3 hundred and eighty-seven, entitled an act to amend an act
- 4 incorporating the City of Waterville, as amended by chapter
- 5 sixteen of the private and special laws of nineteen hundred
- 6 and seventeen, is hereby amended by striking out the words

7 "one million dollars" in the eleventh line of the seventh 8 section of said act, and inserting in the place of said words, 9 the words 'one million five hundred thousand,' so that the 10 said seventh section of said act as amended shall read as 11 follows:

'Sect. 7. No money shall be paid out of the city treasury 2 except on orders drawn and signed by the mayor, designat-3 ing the fund or appropriation from which said orders shall 4 be paid, nor unless the same shall be first granted or appro-5 priated therefor by the city council, and the city council 6 shall secure a prompt and just accountability by requiring 7 bonds of sufficient penalty and surety or sureties, from all 8 persons trusted with the receipt, custody or disbursement of 9 money; the city council shall have the care and superintend-10 ence of the city buildings and the custody and management 11 of all city property, with power to let or sell what may be 12 legally let or sold, and to purchase, take and hold, in the 13 name of the city, real and personal property for municipal 14 purposes to an amount not exceeding one million, five hun-15 dred thousand dollars, and shall, as often as once a year, 16 cause to be published for the information of the inhabitants, 17 a particular account of receipts and expenditures, and a 18 schedule of city property.'
