IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

RESOLVE, for the Laying of the County Taxes for the Year
Nineteen Hundred and Twenty-five.

EMERGENCY PREAMBLE

Whereas, the several counties hereinafter named have certain expenses and liabilities which must be met as they become due, and such counties have no source of revenue except the taxes herein mentioned, therefore, the appropriations called for in this resolve are immediately necessary for the preservation of the public peace, health, and safety, and in the judgment of this legislature these facts constitute an emergency as contemplated by the constitution, be it, therefore,

Resolved: That the sum annexed to the counties in the
2 following schedule is hereby granted as a tax on each coun-

3 ty respectively, to be appropriated, assessed, collected and
 4 applied to the purpose of paying the debts and necessary
 5 expenses of the same and for other purposes of law, for the
 6 year nineteen hundred and twenty-five.
