### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Change the Grades of the Apple Packing Law.

Be it enacted by the People of the State of Maine, as follows:

That chapter thirty-six of the revised statutes of nineteen

- 2 hundred and sixteen, as amended by chapter ninety-four of
- 3 the public laws of nineteen hundred and twenty-three, is
- 4 hereby amended by striking out all of section twenty-seven
- 5 and inserting in its place the following, so that said section
- 6 shall read as follows:

'The standard grade for apples, when packed in closed 2 packages, shall be as follows:

'First: MAINE STANDARD FANCY shall consist of

- 2 well matured apples of one variety, of normal shape and
- 3 above the average size and color for the variety, sound and

4 free from worm holes, bruises, scab, or other defect that 5 materially injures the appearance or useful quality of the 6 apple and shall be properly packed in clean, strong pack-7 ages.

'Second: MAINE STANDARD A, shall consist of well 2 matured apples of one variety of normal shape and good 3 color for the variety, sound and free from all defects such 4 as worm holes, bruises, scab or other defect that materially 5 injures the appearance or useful quality of the apple, and 6 shall be properly packed in clean, strong packages.

'Third: MAINE STANDARD B, shall consist of well 2 matured apples of one variety, sound, and normal shape, 3 and shall be properly packed in clean, strong packages.

'Fourth: MAINE ORCHARD RUN, shall consist of well matured apples of one variety of the Maine Standard Fancy, Maine Standard A and Maine Standard B grades, and shall be properly packed in clean, strong packages.

'Fifth: UNCLASSIFIED. Apples not conforming to 2 the foregoing conditions as to variety, size and other con-3 ditions, shall be classed as Unclassified.

'Sixth: The minimum size of the fruit in all classes or 2 grades shall be determined by taking the transverse di-3 ameter of the smallest fruit in the package at right angles 4 to the stem and blossom end. Minimum sizes shall be stated 5 in variations of one-quarter of an inch like two inches, two 6 and one-quarter inches, two and one-half inches, two and 7 three-quarters inches, three inches, three and one-quarter 8 inches and so on, in accordance with the fact.

'Seventh: Minimum sizes may be designated by figures 2 instead of words. The word "minimum" may be designated by using the abbreviation "min."

'Eighth: No shipment, consignment or lot of apples in 2 closed packages shall be condemned without examination 3 of at least five per cent of the packages in such shipment, 4 consignment or lot. Any shipment, consignment or lot in 5 which five per cent of the packages are found to contain 6 fruit below the grade marked on the container may be con-7 demned by the commissioner of agriculture or his author-8 ized deputies. No closed package of apples shall be con-9 sidered below grade unless five per cent of the fruit con-10 tained therein is below the grade marked on the outside of 11 the container.'
