IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

RESOLVE, in Favor of State School for Girls.

Resolved: That there be and hereby is appropriated for
2 the State School for Girls for the fiscal year July first,
3 nineteen hundred and twenty-five, to June thirtieth, nine-
4 teen hundred and twenty-six, inclusive, the sum of eighty-
5 three thousand five hundred and six dollars and fifty-nine
6 cents for the purposes hereinafter specified, namely:

JULY 1, 1925 TO JUNE 30, 1926

Personal services for salaries and wages of offi-

cers and employees,

\$25,000.00

Maintenance for food supplies, wearing apparel,

all articles of personal clothing and materials for their fabrication and repair,	42,000.00
Repairs and equipment, all materials, supplies and labor required for repairs and upkeep of grounds, buildings, and attached fixtures,	13,615.63
Interest on trust funds,	540.96
Necessary repairs and permanent improvements,	2,350.00

And be it further resolved, that there be and hereby is
 2 appropriated for the State School for Girls for the fiscal
 3 year July first, nineteen hundred and twenty-six, to June
 4 thirtieth, nineteen hundred and twenty-seven, inclusive, the
 5 further sum of eighty thousand four hundred thirty-nine
 6 dollars and twenty-two cents for the purposes hereinafter
 7 specified, namely:

JULY 1, 1926 TO JUNE 30, 1927

Personal services for salaries and wages of offi- cers and employees,	\$25,000.00
Maintenance for food supplies, wearing apparel, all articles of personal clothing and materials for their fabrication and repair,	42,000.00
Repairs and equipment, all materials, supplies and labor required for repairs and upkeep of grounds, buildings, and attached fixtures,	12,898.26
Interest on trust funds,	540.96

Provided, that any balance of the sums above appropriated
 2 for the fiscal year July first, nineteen hundred and twenty-
 3 five to June thirtieth, nineteen hundred and twenty-six,

4 which may remain unexpended at the end of said fiscal year
5 shall be available for expenditure during the fiscal year
6 July first, nineteen hundred and twenty-six to June thir-
7 tieth, nineteen hundred and twenty-seven, and provided fur-
8 ther, that the governor and council may by order, upon
9 recommendation of the trustees of said institution, author-
10 ize the use of unexpended balances of any of the above ap-
11 propriations to meet deficiencies in other appropriations for
12 the same institution.
