RESOLVE, in Favor of State School for Boys.

Resolved: That there be and hereby is appropriated for

- 2 the State School for Boys for the fiscal year July first, nine-
- 3 teen hundred and twenty-five, to June thirtieth, nineteen
- 4 hundred and twenty-six, inclusive, the sum of seventy-four
- 5 thousand and forty-two dollars for the purposes hereinafter
- 6 specified, namely:

JULY 1, 1925, TO JUNE 30, 1926

Personal services for salaries and wages of officers and employees,

Maintenance for food supplies, wearing apparel. all articles of personal clothing and materials for their fabrication and repair. 31,000.00 Repairs and equipment, all materials, supplies and labor required for repairs and upkeep of grounds, buildings, and attached fixtures. 16,000.00 Interest on trust funds. 42.00 New construction and permanent improvements, rearrangement of heating system, 7,500.00 And be it further resolved, that there be and hereby is 2 appropriated for the State School for Boys for the fiscal 3 year July first, nineteen hundred and twenty-six, to June 4 thirtieth, nineteen hundred and twenty-seven, inclusive, the 5 further sum of sixty-six thousand five hundred and forty-6 two dollars for the purposes hereinafter specified, namely: JULY 1, 1926 TO JUNE 30, 1927 Personal services for salaries and wages of officers and employees, \$19,500.00 Maintenance for food supplies, wearing apparel, all articles of personal clothing and materials

for their fabrication and repair,

Repairs and equipment, all materials, supplies
