STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Chapter One Hundred and Forty of the Private and Special Laws of 1921, Relating to the Farmington Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Chapter 140 of the Private and Special Laws of 1921, is

- 2 hereby amended by adding in the seventeenth line after the
- 3 word "County" the words, 'And in addition thereto he shall
- 4 receive the sum of \$300.00 annually to be used by him as
- 5 clerk hire for said Court and to be payable in the same man-
- 6 ner as his salary is paid.' So that said Chapter as amended,
- 7 shall read as follows:

'The judge of said court shall demand and receive the

2 same fees as are allowed to trial justices for like services 3 except that he shall demand and receive for a complaint and 4 warrant in criminal cases one dollar; for the entry of a 5 civil action fifty cents; and for the trial of an issue, civil 6 or criminal, one dollar for the first day and two dollars for 7 each day after the first occupied in such cause, to be paid 8 to him by the plaintiff in civil cases before trial, who shall 9 recover the same as costs if he prevail in the suit. All 10 fees, civil or criminal, shall inure to the County of Franklin 11 and shall be paid over to the treasurer of said county by 12 said judge on the first day of each month, except fines re-13 covered for the violation of the inland fish and game laws 14 of the state, which said fines shall be paid by said judge to 15 the commissioner of inland fisheries and game as required 16 by section eighty-six of chapter two hundred and nineteen 17 of the public laws of nineteen hundred and seventeen. 18 judge of said court shall receive an annual salary of six 19 hundred dollars in full for all services performed as judge 20 of said municipal court, payable on the first day of each 21 month from the treasury of Franklin County. And in addi-22 tion thereto he shall receive the sum of three hundred dol-23 lars annually to be used by him as clerk hire for said court 24 and to be payable in the same manner as his salary is paid. 25 All expenses of said court, including blank books of record, 26 docket, and blanks necessary for the use of said court shall 27 be paid from the treasury of said County of Franklin on 28 vouchers approved by the county commissioners of said

29 county, and said commissioners shall audit and approve all 30 accounts of said judge annually on the last day of Decem-31 ber, for the previous year.'
