STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Chapter 197, Section 8, Laws of 1917, as Amended by Chapter 217, Laws of 1919, Relating to Appropriations of the State Department of Health.

Be it enacted by the People of the State of Maine, as follows:
Section 1. Section eight of chapter one hundred and nine2 ty-seven of the public laws of nineteen hundred and seven3 teen, as amended by chapter one hundred and seventy-two
4 of the public laws of nineteen hundred and nineteen, as
5 amended by chapter one hundred and sixty-two of the pub6 lic laws of nineteen hundred and twenty-one, as amended
7 by chapter two hundred and seventeen, public laws of nine8 teen hundred and twenty-three, is hereby further amended

9 by striking out the word "fifty-three" in the second line 10 thereof and substituting therefor the word 'sixty-five,' so that 11 said section eight, as amended, shall read as follows:

'Sect. 8. Appropriation increased from \$53,000 to \$65,000. 2 The sum of fifty-three thousand dollars shall be annually 3 appropriated for the purposes set forth in sections one to six 4 inclusive, and section seven of this act.'

Sect. 2. Section two of chapter one hundred and seventy-2 two of the public laws of nineteen hundred and nineteen, 3 enacting section sixteen as an additional section to chapter 4 one hundred and ninety-seven of the public laws of nine-5 teen hundred and seventeen, as amended by chapter one 6 hundred and sixty-two of the public laws of nineteen hun-7 dred and twenty-one, as amended by chapter two hundred 8 and seventeen, public laws of nineteen hundred and twenty-9 three, is hereby amended by striking out the word "thirty-10 eight" in the first line of said section sixteen, and substitut-11 ing therefor the word 'forty-six'; so that said section sixteen, 12 as amended, shall read as follows:

'Sect. 16. Appropriation increased from \$38,000 to \$44,000. 2 The sum of forty-six thousand dollars shall be appropriated 3 annually to the state department of health for the purpose 4 of carrying out the provisions of sections six, ten, eleven, 5 twelve, thirteen and fourteen.'

Sect. 3. Chapter nineteen of the revised statutes, as amend-2 ed by chapter three hundred and one of the public laws of 3 nineteen hundred and seventeen, and as further amended

4 by chapter one hundred and seventy-two of the public laws 5 of nineteen hundred and nineteen, as further amended by 6 chapter one hundred and sixty-two of the public laws of 7 nineteen hundred and twenty-one, as amended by chapter 8 two hundred and seventeen, public laws of nineteen hundred 9 and twenty-three, is further amended by striking out the 10 word "fourteen" in the third line of section one hundred 11 and thirty-one and substituting therefor the word 'eighteen,' 12 so that said section one hundred and thirty-one, as amended, 13 shall read as follows:

'Sect. 131. Appropriation increased from \$14,000 to \$18,-2 000. For the purpose of enabling the state board of health to 3 carry out the provisions of this act there is hereby appro-4 priated the sum of eighteen thousand dollars.'
