STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Section One of Chapter Ninety-seven of the Revised Statutes, Relating to Right to Erect and Maintain Mill Dams and to Divert Water by a Canal for Mills. Be it enacted by the People of the State of Maine, as follows: Section one of chapter ninety-seven of the revised statutes 2 of nineteen hundred and sixteen is hereby amended by add-3 ing to said section after the word "expressed" in said sec-4 tion the following:

'Any dam raising the level of water in ponds, lakes, or 2 streams, for the purpose of collecting and storing water, 3 for use at other water mills and dams, owned by the owners 4 of said dam, and located below said dam on the same stream

5 or water to which said stream is tributary, shall not be 6 erected, except, such dam be authorized by special act of 7 the legislature or by decree of the public utilities commis-8 sion as hereinafter provided.

'Any man on his own land desiring to erect a water mill 2 and dams or dam for the purpose of collecting and storing 3 water for use at other water mills and dams owned by 4 him on the stream below or water to which said stream 5 is tributary, may petition the public utilities commission for 6 permission to erect such dam, setting forth the proposed 7 location of said dam, its height and the area to be flowed, 8 and after such notice as the said commission may order, 9 and public hearing, the public utilities commission by de-10 cree, which shall bear in writing the consent thereto of the 11 governor and a majority of the members of the executive 12 council, may authorize the erection of such dam.'

So that said section as amended shall read as follows:

'Any man may on his own land, erect and maintain a 2 water mill and dams to raise water for working it, upon 3 and across any stream, not navigable; or, for the purpose 4 of propelling mills or machinery, may cut a canal and erect 5 walls and embankments upon his own land, not exceeding 6 one mile in length, and thereby divert from its natural chan-7 nel the water of any stream not navigable, upon the terms. 8 and conditions, and subject to the regulations hereinafter 9 expressed.

'Any dam raising the level of water in ponds, lakes, or

2 streams, for the purpose of collecting and storing water, 3 for use at other water mills and dams, owned by the owners 4 of said dam, and located below said dam on the same stream 5 or water to which said stream is tributary, shall not be 6 erected, except, such dam be authorized by special act of 7 the legislature or by decree of the public utilities commis-8 sion as hereinafter provided.

'Any man on his own land desiring to erect a water mill 2 and dams or dam for the purpose of collecting and storing 3 water for use at other water mills and dams owned by him 4 on the stream below or water to which said stream is tribu-5 tary, may petition the public utilities commission for per-6 mission to erect such dam, setting forth the proposed loca-7 tion of said dam, its height and the area to be flowed, and 8 after such notice as the said commission may order, and 9 public hearing, the public utilities commission by decree, 10 which shall bear in writing the consent thereto of the gov-11 ernor and a majority of the members of the executive coun-12 cil, may authorize the erection of such dam.'
