IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

RESOLVE, in Favor of the Maine School for Feeble Minded for Maintenance for the Fiscal Years Nineteen Hundred and Twenty-six and Nineteen Hundred and Twenty-seven.

Resolved: That there be, and hereby is, appropriated for 2 the Maine School for Feeble Minded:

1925-26 1926-27

For personal services, namely, for salaries and wages for all officers and employees, except for those wholly engaged in repairs of buildings and equipment, for the two years, July first, nineteen hundred and twenty five, to June thirtieth,

nineteen hundred and twenty-six, the sum of eighty-one thousand dollars; July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, the sum of eighty-one thousand dollars,

For maintenance, namely, for food supplies, wearing apparel, all articles of personal clothing and materials for their fabrication and repair, all materials and supplies incident to the maintenance of the institution and patients thereof, whether present or absent, and all farm feed for the two years, July first, nineteen hundred and twenty-five, to June thirtieth, nineteen hundred and twentysix, the sum of one hundred fifteen thousand, five hundred dollars; July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, the sum of one hundred fifteen thousand, five hundred dollars, \$115,500.00 \$115,500.00

For repairs and equipment, namely, all materials, supplies, and labor required for repairs, additions, and up-keep of grounds, buildings and attached fixtures; all additions to and repairs and replacements of furniture and equipment, including farm equipment and live stock (exclusive of farm feed) and all personal services rendered wholly in connection with repair work for the two years: July first, nineteen hundred and twenty-five, to June thirtieth, nineteen hundred and twenty-six, the sum of forty-seven thousand, five hundred dollars; July first, nineteen hundred and twenty-six, to June thirtieth, nineteen hundred and twenty-seven, the sum of forty-seven thousand,

five hundred dollars.

Provided, that any balance of the sums above appropriated 2 for the year nineteen hundred and twenty-six, which may 3 remain unexpended at the end of the year, shall be available 4 for expenditures during the year nineteen hundred and 5 twenty-seven, and provided further, that the governor and 6 council may, by order, upon recommendation of the trus-7 tees of said institution, authorize the use of unexpended 8 balances of any of the above appropriation to meet deficieng cies in other appropriations for the same institution.
