STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Section Three of Chapter Three Hundred and Forty-six of the Private and Special Laws of Nineteen Hundred and Five, as Amended by Chapter Twenty-seven of the Private and Special Laws of Nineteen Hundred and Fifteen, as Amended by Chapter One Hundred and Four of the Private and Special Laws of Nineteen Hundred and Nineteen, as Amended by Chapter One Hundred and Fiftythree of the Private and Special Laws of Nineteen Hundred and Twenty-one, Providing for and Fixing the Salaries of the Probation Officer and Assistant Probation Officer for the County of Cumberland.

Be it enacted by the People of the State of Maine, as follows:

Section three of chapter three hundred and forty-six of 2 the private and special laws of nineteen hundred and five, 3 as amended by chapter twenty-seven of the private and spe-4 cial laws of nineteen hundred and fifteen, as amended by 5 chapter one hundred and four of the private and special 6 laws of nineteen hundred and nineteen, as amended by 7 chapter one hundred and fifty-three of the private and 8 special laws of nineteen hundred and twenty-one, is hereby 9 amended by striking out the word "fifteen" in the second 10 line thereof and inserting in place thereof the word 'seven-11 teen,' and by striking out the words "one thousand" in the 12 sixth line thereof and inserting in place thereof the words 13 'thirteen hundred,' so that said section as amended shall read 14 as follows:

'Sect. 3. The salary of said probation officer shall be 2 seventeen hundred dollars per year, payable monthly in 3 equal instalments by the county treasurer of the county of 4 Cumberland, upon warrants drawn by the county com-5 missioners of said county. The salary of said assistant 6 probation officer shall be thirteen hundred dollars per year, 7 payable monthly in equal instalments by the county treas-8 urer under the same conditions as is provided for the pay-9 ment of the salary of the probation officer.

When a person has been placed on probation the court 2 may direct and authorize the probation officer to expend 3 for the temporary support of such person, or for his trans-4 portation, or for both such purposes such reasonable sum

5 as the court shall consider expedient and any sums so ex-6 pended, together with actual disbursements for necessary 7 expenses made by said probation officer while in the per-8 formance of his duty, shall be reimbursed to him out of 9 the county treasury of the county of Cumberland after 10 approval of the recorder of said municipal court when said II expenditure was made by order of the judge of said court, 12 or, in his absence, the recorder, or when said duties were 13 performed on account of said municipal court, and by the 14 clerk of said superior court when the expenditure was made 15 by order of the judge thereof, or when said duties were 16 performed on account of said superior court, provided that 17 said officer shall not be allowed in all for such disburse-18 ments exclusive of said expenditures made by special order 19 of said courts, a greater sum than three hundred dollars 20 in any one year.'
