STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

AN ACT to Amend Chapter One Hundred Ninety-seven, Section Eight, Laws of Nineteen Hundred Seventeen, as Amended by Chapter Two Hundred Seventeen, Laws of Nineteen Hundred Nineteen, Relating to Appropriations of the State Department of Health.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section eight of chapter one hundred ninety-
2 seven of the public laws of nineteen hundred seventeen, as
3 amended by chapter one hundred seventy-two of the public
4 laws of nineteen hundred nineteen, as amended by chapter
5 one hundred sixty-two of the public laws of nineteen hun-
6 dred twenty-one, as amended by chapter two hundred sev-

7 enteen, public laws of nineteen hundred twenty-three, is
8 hereby further amended by striking out the word “fifty-
9 three” in the second line thereof and substituting therefor
10 the word ‘fifty-eight,’ so that said section eight, as amended,
11 shall read as follows:

‘Sect. 8. The sum of fifty-eight thousand dollars shall be
2 annually appropriated for the purposes set forth in sections
3 one to six inclusive, and section seven of this act.’

Sect. 2. Chapter nineteen of the revised statutes, as
2 amended by chapter three hundred one of the public laws
3 of nineteen hundred seventeen, and as further amended by
4 chapter one hundred seventy-two of the public laws of nine-
5 teen hundred nineteen, as further amended by chapter one
6 hundred sixty-two of the public laws of nineteen hundred
7 twenty-one, as amended by chapter two hundred seventeen,
8 public laws of nineteen hundred and twenty-three, is fur-
9 ther amended by inserting the word ‘annually’ in the third
10 line of section one hundred thirty-one after the word “here-
11 by,” so that said section one hundred thirty-one, as amended,
12 shall read as follows:

‘Sect. 131. The sum of fourteen thousand dollars. For
2 the purpose of enabling the state board of health to carry
3 out the provisions of this act there is hereby annually appro-
4 priated the sum of fourteen thousand dollars.’
