STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

RESOLVE, in Favor of the Maine State Prison for
Maintenance and Current Expenses.

Resolved: That there be, and hereby is, appropriated for
2 the Maine State Prison for the fiscal year July first, nine-
3 teen hundred and twenty-five, to June thirtieth, nineteen
4 hundred and twenty-six, inclusive, the sum of eighty-one
5 thousand three hundred dollars for the purposes hereinafter
6 specified, namely:

July 1, 1925—June 30, 1926

Personal services of officers and employees, fifty
thousand dollars, \$50,000.00

Maintenance, including food supplies, clothing,
repairs on buildings and general expenses, 28,000.00
twenty-eight thousand dollars,

Retiring and pensioning prison officials, three

thousand three hundred dollars, 3,300.00

And be it further resolved that there be, and hereby is,
 2 appropriated for the Maine State Prison for the fiscal year
 3 July first, nineteen hundred and twenty-six, to June thirtieth,
 4 nineteen hundred and twenty-seven, inclusive, the further
 5 sum of eighty-one thousand three hundred dollars for the
 6 purposes hereinbefore specified, divided as follows, namely:

July 1, 1926—June 30, 1927

Personal services of officers and employees, fifty

thousand dollars, \$50,000.00

Maintenance, including food supplies, clothing,

repairs on buildings and general expenses,
 twenty-eight thousand dollars, 28,000.00

Retiring and pensioning prison officials, three

thousand three hundred dollars, 3,300.00

PERSONAL SERVICES

The within fifty thousand dollars is the actual amount needed
 to cover the payroll under this item.

MAINTENANCE

Save for the fiscal years 1923-1924 and 1924-1925, twenty-
 eight thousand dollars is the amount which has been appropri-
 ated to cover this item for several years. By reason of the
 high prices received for goods manufactured at the prison
 prior to 1923-1924 this sum was cut down to twenty thousand
 dollars. The larger sum is requested for the coming fiscal

years first, for the reason that the market has been largely lost to the goods produced at the prison by reason of the fire which destroyed the shops in September, 1923; and second, because the prison population is averaging at the present time above fifty men more than the usual population, with more coming.

RETIRING AND PENSIONING PRISON OFFICIALS

Under the law there are several officials on the retired list who are entitled to half pay. The sum asked for is based upon the actual payroll at the present time.
