## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Appropriate Moneys for the Expenditures of the Government for the Remaining Months of the Fiscal Year Ending June Thirtieth, Nineteen Hundred and Twenty-five.

Whereas, the necessity for the appropriation of moneys for the maintenance of the several branches of the state government, its departments and institutions and for other purposes for the remaining months of the fiscal year ending June thirtieth, nineteen hundred and twenty-five, creates an emergency, whereby the public peace, health and safety are endangered and emergency legislation is necessary to protect the welfare and credit of the state and conserve the various activities relating to the public peace, health and safety which are involved. Be it enacted by the People of the State of Maine, as follows:

In order to provide for the payment of certain sums of 2 money under two resolves of this legislature approved on 3 the fifth day of February, nineteen hundred and twenty-4 five and the twenty-seventh day of March, nineteen hundred 5 and twenty-five, providing in part for the necessary ex-6 penditures of government and for other purposes for the 7 remaining months of the fiscal year ending June thirtieth, 8 nineteen hundred and twenty-five, the following sums are 9 hereby appropriated, and except where otherwise specially 10 provided, the governor with the advice and consent of the 11 council, is hereby authorized at any time prior to the thirty-12 first day of December, nineteen hundred and twenty-five, 13 to draw his warrant on the state treasurer for the same.

For the payment of certain claims and departmental over-2 drafts and to provide for carrying on the activities of de-3 partments and institutions, and for other purposes, for the 4 remaining months of the fiscal year ending June thirtieth, 5 nineteen hundred and twenty-five, as provided by a resolve 6 approved March twenty-seventh, nineteen hundred and 7 twenty-five, two hundred and seventy-seven thousand nine 8 dollars and four cents (\$277,009.04).

For the purpose of paying the amount appropriated in 2 said resolve for normal school extensions, the following 3 amounts heretofore appropriated to the state superintendent 4 of public schools are hereby transferred to the appropriation of said department for normal school extensions from

6 balances of the following appropriations to said department,	
7 viz:	
From training rural teachers, seven thousand	
2 five hundred dollars,	\$7,500.00
From superintendence of towns comprising	
2 school unions, four thousand dollars,	4,000.00
From pensions for retired teachers, three thou-	
2 sand, five hundred dollars,	3,500.00
From general office expenses, one thousand	
2 dollars,	1,000.00
From aid to academies, two thousand dollars,	2,000.00
From state school fund, one thousand eight	
2 hundred and twenty-four dollars and sixty-	
3 seven cents,	1,824.67

A total of nineteen thousand, eight hundred and

2 twenty-four dollars and sixty-seven cents, \$19,824.67

For the payment of expenses of the electoral college as

2 provided by a resolve approved February fifth, nineteen

3 hundred and twenty-five, the sum of three hundred and

4 fifty-four dollars, (\$354.00).

In view of the emergency cited in the preamble this act 2 shall take effect when approved.
