STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-FIVE

Senate Document Number 102, is hereby amended by
2 striking out all of said act, except the title, and substituting
3 in place thereof the following:

Chapter four hundred eighty-five of the private and special
2 laws of nineteen hundred and one, as amended by chapter
3 three hundred and thirty-one of the private and special
4 laws of nineteen hundred and nine, is hereby further amended
5 ed by striking out all of section eight of chapter three
6 hundred thirty-one of the private and special laws of nineteen
7 hundred and nine, and substituting therefor the following
8 section:

'Sect. 8. As compensation for his services in that capacity

2 the judge of said court shall receive an annual salary of
3 sixteen hundred dollars, payable in quarterly installments
4 from the treasury of the county of Somerset, on the first
5 days of January, April, July and October; and all fees
6 received by him in said capacity shall be by him turned
7 over to the county of Somerset. He shall account quarterly
8 under oath to the county treasurer for all fees received by
9 him, specifying the items, and shall pay the same to said
10 treasurer quarterly, on the first days of January, April,
11 July and October; and he shall annually, and as much
12 oftener as required by the county commissioners of said
13 county, produce before said commissioners the dockets,
14 records and accounts of said court; and be inquired of by
15 them as fully as they deem necessary with reference to all
16 his official acts. The fees to be demanded and received by
17 said judge shall remain as heretofore, except that the fee
18 for each blank writ, signed and sealed, shall be four cents,
19 including the summons for same.'

Sect. 2. Chapter four hundred and eighty-five of the
2 private and special laws of nineteen hundred and one, as
3 amended by chapter three hundred and thirty-one of the
4 private and special laws of nineteen hundred and nine, is
5 hereby amended by striking out part three of section three
6 of chapter three hundred thirty-one of the private and
7 special laws of nineteen hundred and nine, and substituting
8 in its place the following:

'Part III of Sect. 3. Original jurisdiction concurrent with

2 the supreme judicial court and the municipal court of Pitts-
3 field of all civil actions wherein the debt or damage de-
4 manded exceed twenty dollars and do not exceed two hun-
5 dred dollars, and any defendant or a person summoned as
6 trustee resides in the county of Somerset.'
