## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

RESOLVE, in Favor of the National Conference of Commissioners on Uniform State Laws and of the Commissioners from Maine for the Promotion of Uniformity of Legislation in the United States.

Resolved: That the sum of five hundred dollars for the 2 period from July first, nineteen hundred and twenty-five, 3 to July first, nineteen hundred and twenty-six, and the sum 4 of five hundred dollars for the period from July first, nineteen hundred and twenty-six, to July first, nineteen hunded and twenty-seven, be and hereby is, appropriated, of 7 which two hundred dollars for the year beginning July first, 8 nineteen hundred and twenty-five, and two hundred dollars

9 for the year beginning July first, nineteen hundred and 10 twenty-six, shall be paid to the National Conference of 11 Commissioners on Uniform State Laws, and so much of 12 the balance for each year beginning July first, nineteen hun-13 dred and twenty-five, and July first, nineteen hundred and 14 twenty-six, as may be necessary shall be paid to the com-15 missioners from Maine for the promotion of uniformity 16 of legislation in the United States, for their expenses in 17 attending the National Conference of Commissioners on 18 Uniform State Laws, for drafting and printing reports, 19 postage, and for their other expenses in performing the 20 duties of said office. All as recommended in report of the 21 committee on budget.

#### STATEMENT OF FACTS

'i...e National Conference of Commissioners on Uniform State Laws consists of three to five members, from each of the several states and jurisdictions of the United States. The present Commissioners from Maine are Hon. P. H. Gillin of Bangor, Harold H. Murchie of Calais and Harry L. Cram of Portland.

The National Conference meets annually, and very many of the uniform laws which the Conference have worked out have been adopted by many of the states of the Union, five already having been adopted by this state. The resolve itself explains fully the purposes of the appropriation.
