STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the Property of Extinct or Disbanded Congregational Churches, Parishes or Societies.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Chapter four hundred forty-seven of the priv-

- 2 ate and special laws of the year one thousand eight hundred
- 3 and ninety-three is hereby amended by striking out the whole
- 4 of Section 1 of said chapter and inserting in place thereof
- 5 the following, so that said section as amended shall read
- 6 as follows:

Section 1. The Congregational Conference and Mission-

- 2 ary Society of Maine, a corporation duly organized and
- 3 existing under the laws of the State of Maine, shall be and
- 4 become vested with the property and effects of any extinct

5 or disbanded Congregation church, parish or society within 6 this state in trust to apply the same to paying the debts; if 7 any, of such extinct or disbanded church, parish or society 8 and to use any surplus for the purposes and objects of said 9 The Congregational Conference and Missionary Society of 10 Maine, and may sell and convert such property and effects II into money; provided, however, that in the sale and dis-12 position of property so devolving on said The Congrega-13 tional Conference and Missionary Society of Maine said 14 Society shall be deemed in respect to the right and power 15 of possession control, disposal and conveyance, the legal 16 successor of such extinct or disbanded Congregational 17 church, parish or society; and in the case of sale of such 18 property said The Congregational Conference and Mission-19 ary Society of Maine may apply to the Supreme Judicial 20 Court or to the Probate Court within the county where such 21 property is situated for a judicial order authorizing the sale 22 thereof, and such order shall be authority for making such 23 sale.'

- Sect. 2. Said chapter is further amended by striking out 2 the whole of Section 2 of said chapter, and inserting in place 3 thereof the following, so that said section as amended shall 4 read as follows:
- 'Sect. 2. The Congregational Conference and Missionary 2 Society of Maine, in order to determine when any such 3 Congregational church, parish or society is extinct or dis-4 banded, is hereby empowered to call a council of the local

5 Association of Congregational churches in which said church, 6 parish or society is situated, and the finding of such associa7 tion, together with the decree of the court, shall be its
8 authority for procedure. Before the sale of any property
9 by said The Congregational Conference and Missionary
10 Society of Maine under order of court, notice of said sale
11 shall be published at least two weeks before the date of sale
12 in a paper of wide circulation in the vicinity of the church
13 formerly used by such extinct or disbanded church, parish
14 or society.'
