STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to Expenditures and Returns of Candidates for Public Office.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section eighteen of chapter six of the revised

- 2 statutes is hereby amended by inserting the words 'and news-
- 3 paper advertising' after the word "traveling" in the thir-
- 4 teenth line of said section, and by inserting the words 'and
- 5 newspaper advertising' after the word "traveling" in the
- 6 sixty-first line of said section, so that said section as amended
- 7 shall read as follows:

'Sect. 18. Each candidate, so nominated, shall, with such

If any statement in said return is wilfully false it shall be 2 deemed to be perjury and shall be punished accordingly. 3 No expenditures shall be so made, or liabilities be so in-4 curred except for the purposes named aforesaid in said 5 return. The subdivision "miscellaneous" shall not exceed 6 ten per cent of the total amount hereinafter permitted, and 7 shall include no items not legitimate under sections one 8 hundred and twenty-four to one hundred and thirty-two, 9 both inclusive, of chapter seven; subsections (d) and (e) 10 of section one hundred and twenty-eight of chapter seven, 11 as applied to primary elections, are to be construed as if 12 reading as follows:

'(d) of renting and furnishing rooms to be used by can-2 didates or their political agents, and for the reasonable en-3 tertainment and refreshment exclusive of alcoholic bever-4 ages, of political agent;'

'(e) of compensating clerks and other persons employed 2 in candidates' rooms and at the polls.' Political agents of 3 candidates appointed under the provisions of said sections 4 shall, within fifteen days after the date of the primary elec-5 tion, make to the secretary of state the return required by 6 this section of candidates, omitting only therefrom any sums 7 expended by them for the actual personal expenses of the 8 candidate for postage, telegrams, telephones, stationery, ex-9 press and traveling and newspaper advertising; and the form 10 of the return shall be varied accordingly. Candidates who II are their own political agents need not make a separate 12 return in the latter capacity. Any political agent failing 13 to make return within the time required, shall be fined 14 twenty-five dollars for each day on which he is in default, 15 unless he shall be excused by the court, but such failure 16 shall not avoid or affect the nomination of the candidate. 17 The returns aforesaid shall be open to public inspection for 18 one year and then be destroyed. The failure of any can-10 didate to file a return within the time required by section 20 seventeen, shall render his nomination void.'

Sect. 2. Section one hundred twenty-seven of chapter 2 seven of the revised statutes is hereby amended by inserting 3 after the word "traveling" in the fourth and fifth lines 4 thereof, the words 'and newspaper advertising,' so that said 5 section, as amended, shall read as follows:

'Sect. 127. No person other than a treasurer or political 2 agent shall pay any of the expenses of any election, caucus,

- 3 or primary election, except that a candidate may pay his
- 4 actual personal expenses for postage, telegrams, telephones,
- 5 stationery, express, and traveling and newspaper advertis-
- 6 ing; but the provisions of this section shall not apply to
- 7 non-partisan election and ante-election expenses paid for
- 8 out of the public moneys of the state, or of any town, city
- 9 or other municipality.'
