STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Establish and Maintain Free Employment Offices.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The commissioner of labor and industry may

- 2 establish and maintain in such cities as may be selected by
- 3 it after investigation, with the approval of the governor and
- 4 council, employment offices for the purpose of bringing to-
- 5 gether those seeking employment and those desiring to em-
- 6 ploy, and may maintain such offices now established. The
- 7 commissioner shall make an annual report as to free em-
- 8 ployment offices.

Sect. 2. The commissioner of labor and industry shall

- 2 appoint such assistants or clerks as he may deem necessary
- 3 for the proper conduct of such offices and shall fix their

- 4 compensation subject to the approval of the governor and 5 council.
- Sect. 3. Such employment offices shall receive applications 2 from those seeking employment and from those desiring to 3 employ, and shall register them in such manner as may be 4 prescribed by the commissioner, and shall take such other 5 action as the commissioner may deem best to promote the 6 purposes of said offices. Said employment offices shall also 7 receive applications from alien immigrants seeking employ-8 ment in agricultural labor and from those desiring to employ immigrants in agricultural labor, and shall take such 10 other action as the commissioner may deem best to promote 11 a more general distribution of alien immigrants throughout
 - Sect. 4. In registering applications for employment and 2 for employees wanted, preference shall be given to residents 3 of this state.

12 the agricultural sections of the commonwealth.

- Sect. 5. No fees, direct or indirect, shall, in any case, be 2 taken from those seeking the benefits from said employment 3 offices.
- Sect. 6. Said employment offices shall be established and 2 maintained in conjunction with the United States.
- Sect. 7. There shall be appropriated for salaries and for 2 contingent expenses for the establishment and maintenance 3 of said employment offices, the sum of thirty-five hundred 4 dollars, each year.
