STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the Edward Little Institute, and to Appoint Trustees of Said Corporation.

Be it enacted by the People of the State of Maine, as follows:

Section 1. George T. Little, of Portland, Noel C. Little,

- 2 of Brunswick, E. Farrington Abbott and George C. Wing,
- 3 Jr., both of Auburn, Luther Dana and Edward L. Pickard,
- 4 both of Westbrook, are hereby appointed and constituted
- 5 trustees of Edward Little Institute, a corporation estab-
- 6 lished at Auburn, in the county of Androscoggin, for the
- 7 purpose, as stated in its charter, of advancing science and
- 8 literature, and promoting morality, piety, and religion.
- Sect. 2. The persons above named, with the trustees of 2 said corporation now surviving, viz: John A. Morrill, of

3 Auburn, Philip Dana, of Westbrook, Jacob R. Little, of
4 New York City, and Frederick W. Pickard, of Wilming5 ton, Delaware, with such others as may be associated with
6 them, not exceeding twenty in all, and their successors, shall
7 be trustees of said corporation, and they and said corpo8 ration shall have, and shall continue to have and to exer9 cise, all the powers granted, and be subject to the same
10 limitations expressed, in an act approved February 25, 1834,
11 entitled "An Act to Incorporate the Trustees of Lewiston
12 Falls Academy," and acts amendatory thereof and addi13 tional thereto, and especially an act approved February 9,
14 1866, entitled "An Act to change the name of the Lewiston
15 Falls Academy," whereby said corporation became known
16 as "Edward Little Institute."

Sect. 3. Any three of said trustees may, after this act 2 becomes in effect, call a meeting of said corporation by a 3 written notice of the time, place, and objects of such meet-4 ing, given to each trustee or directed to him by mail postage 5 prepaid, at least seven days prior to said meeting.
