## STATE OF MAINE

---

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-SEVEN

---

AN ACT Relating to the Registration of Motor Vehicles.

---

Be it enacted by the People of the State of Maine, as follows:

Section forty-seven of chapter two hundred eleven of the  
2 public laws of nineteen hundred twenty-one, as amended  
3 by chapter one hundred twenty-three of the public laws of  
4 nineteen hundred twenty-five, is hereby further amended  
5 by striking out in the last paragraph the whole of the first  
6 sentence and inserting in place thereof the following: 'On  
7 any application for registration, applied for by an owner  
8 resident of this state, of a motor vehicle or trailer, not  
9 including a log hauler or traction engine, during the period  
10 between the first day of April to the thirtieth day of June,

11 both days inclusive, three-fourths of the yearly registration  
12 fee shall be charged, between the first day of July and the  
13 thirtieth day of December, both days inclusive, one-half the  
14 yearly registration fee shall be charged and after the thir-  
15 tieth day of September, one-fourth of the annual registra-  
16 tion fee, and in all cases where the license is issued after  
17 the thirtieth day of September, there shall be paid in addi-  
18 tion one dollar,' so that said paragraph, as amended, shall  
19 read as follows:

    'On any application for registration, applied for by an  
2 owner resident of this state, of a motor vehicle or trailer,  
3 not including a log hauler or traction engine, during the  
4 period between the first day of April to the thirtieth day  
5 of June, both days inclusive, three-fourths of the yearly  
6 registration fee shall be charged, between the first day of  
7 July and the thirtieth day of December, both days inclusive,  
8 one-half the yearly registration fee shall be charged and  
9 after the thirtieth day of September, one-fourth of the  
10 annual registration fee, and in all cases where the license  
11 is issued after the thirtieth day of September, one-fourth  
12 of the annual registration fee and in all cases where the  
13 license is issued, after the thirtieth day of September, there  
14 shall be paid in addition, one dollar. The secretary upon  
15 granting the application shall register in a book or upon  
16 suitable index cards to be kept for the purpose, the vehicle  
17 described in the application, giving to its owner a distinguish-  
18 ing number or other mark, and shall thereupon issue a cer-

19 tificate of registration which shall contain the name, place  
20 of residence and address of the owner.'
