## STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the Board of Harbor Commissioners for the Harbor of Portland.

Be it enacted by the People of the State of Maine, as follows:
Section I. That chapter one hundred and ninety-two of
2 the private and special laws of nineteen hundred and seven3 teen be amended by striking out the whole of section one
4 and inserting as section one of said chapter the following:

'Section I. Four persons, two of whom, at the time of 2 their original appointment, shall be residents of the city of 3 Portland and two of whom, at the time of their original 4 appointment, shall be residents of the city of South Port-5 land, shall be appointed by the governor, with the advice 6 and consent of the council, for a period of four years, to

7 constitute and be known as the Board of Harbor Commis-8 sioners for the city of Portland. Whenever a vacancy occurs 9 in the board, the governor, with the advice and consent of to the council, shall fill such vacancy and the person so ap-II pointed shall hold said office for the term of four years. 12 Whenever a vacancy occurs, by reason of the death or resig-13 nation of any member of said board, the vacancy shall be 14 filled by the appointment of a resident of the same city as 15 the member dying or resigning. In event of the removal 16 of a member of the said board from the county of Cumber-17 land, such member so removing shall lose his right to con-18 tinue as a member of the board and the vacancy so existing 19 shall be filled by the appointment of a resident of the same 20 city from which he was appointed, but any member of the 21 board shall be eligible to reappointment, so long as he con-22 tinues a resident of Cumberland county.'

Sect. 2. That said chapter one hundred and ninety-two 2 be further amended by striking out all of section two of 3 said chapter and inserting as section two the following:

'Sect. 2. The Board of Harbor Commissioners of Portland 2 Harbor, as now constituted, shall continue to exercise the 3 powers conveyed by this chapter. Said board shall meet 4 and from their number elect a chairman and clerk and from 5 time to time adopt such rules and regulations as are neces-6 sary for the proper administration of their duties.'

Sect. 3. That section twelve of said chapter one hundred 2 and ninety-two be amended by adding to said section twelve

3 the words, 'said board shall have the right and power to 4 appoint a member of said board as such harbor master or 5 deputy harbor master,' so that said section, as amended, 6 shall read as follows:

'Sect. 12. Said board shall appoint some competent person 2 as harbor master and also a deputy, but before either shall 3 be gualified to act, their appointment shall be approved by 4 the mayor of the city of Portland; and the persons so ap-5 pointed shall receive such compensation as the city council 6 of said city of Portland shall, from time to time, fix and 7 allow. In the absence, or inability of said harbor master 8 to act, the deputy shall have all the powers and authority 9 of the harbor master. The harbor master and deputy shall 10 hold office for the term of one year from the date of the 11 approval of their appointment; but either may be removed 12 by said board at any time for negligence, inefficiency, or for 13 any other reason deemed sufficient by the board; and said 14 board shall fill the vacancy thereby occasioned, in the manner 15 hereinbefore provided. The harbor master shall be pro-16 vided by the city of Portland with transportation necessary 17 for the performance of his duties. Said board shall have 18 the right and power to appoint a member of said board as 19 such harbor master or deputy harbor master.'
