STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the Registration of Milk Dealers.

Be it enacted by the People of the State of Maine, as follows:

Section five of chapter thirty-seven of the revised statutes,

- 2 as amended by chapter sixty-six of the public laws of nine-
- 3 teen hundred and nineteen and chapter one hundred and
- 4 thirty-two of the public laws of nineteen hundred and twen-
- 5 ty-one, is hereby further amended by striking out wherever
- 6 it may occur in said section, the word "April" and substi-
- 7 tuting in place thereof, the word 'January,' so that said sec-
- 8 tion as amended, shall read as follows:

'Sect. 5. Registration of milk dealers; penalty for refus-

- 2 ing to register or post certificate. Any person, firm, cor-
- 3 poration, association or society who shall sell or deliver

4 milk or cream as a business to any person from a wagon 5 or other conveyance, depot or store, or who shall sell or 6 deliver milk to a hotel, restaurant, boarding-house or any 7 public place, shall be considered a milk dealer within the 8 meaning of this section, and shall on or before the first day 9 of January in each year, apply to the commissioner of ag-10 riculture for registration, furnishing such information as II may be required, upon blanks issued and furnished by the 12 commissioner to such persons as may request the same. 13 Every such registration shall expire on the first day of 14 January, next after its issue and shall be granted only to 15 the milk dealer owning or leasing the vehicle or place from 16 which sales and supplies are to be made and shall not be 17 transferred. Upon receipt of the application for registra-18 tion, containing the information required, and upon being 10 satisfied that all milk is being produced and handled in a 20 sanitary way and is from cows free from disease, the com-21 missioner shall issue to the applicant a certificate of regis-22 tration, which certificate shall be posted in a conspicuous 23 place in the store or depot from which sale or supply is 24 made, and the number of the certificate of registration for 25 each wagon or other vehicle shall be placed in a conspicu-26 ous place on said wagon or other vehicle. The commissioner 27 may cancel the certificate of any dealer, who, after due 28 hearing on complaint by the commissioner or his author-29 ized agent, is found to be selling milk produced or handled 30 under unsanitary conditions or milk from diseased cows.

31 If any person, firm, corporation, association or society de-32 sires to become a milk dealer, as provided by this section, 33 before the first day of January in any year, he or they shall, 34 prior to engaging in the business, register with the com-35 missioner of agriculture in the manner hereinbefore pro-36 vided, for each place or vehicle from which sale or supply 37 is to be made.

Any dealer who neglects or refuses to register with the 2 commissioner of agriculture, or to post certificates of reg3 istration in the store or depot from which sale or supply is 4 made, or to post the number of the certificate of registra5 tion on the wagon or other vehicle from which sale or sup6 ply is made, as provided in this section, or to surrender his 7 certificate to the commissioner when notified in writing that 8 the same has been concelled, and the reason given for can9 cellation, forfeits fifty dollars to be recovered in an action 10 of debt, to be prosecuted in the name of the state by the 11 county attorney for the county in which such violation has 12 occurred; but the provisions of this section shall not apply 13 to milk or cream delivered to a creamery or butter or cheese 14 factory.'
