# STATE OF MAINE

### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Define and Regulate the Sale of Oleomargarine.

Be it enacted by the People of the State of Maine, as follows: Section six of chapter one hundred and thirty of the revised statutes is hereby amended by adding the following: 'Nor shall any person, firm or corporation sell, expose for
sale, or have in his possession with intent to sell oleomargarine unless the original package in which same is shipped
or conveyed from place of manufacture shall have the word
"oleomargarine" in letters three-quarters inch high and of
proportionate width plainly printed or stencilled on the top
or side thereof and unless each carton or wrapper containing said oleomargarine and in which such oleomargarine"

10 printed on two principal display panels in plain Gothic let-II ters not less than twenty point type. When said oleomar-12 garine is sold from a tub or box or other container in which 13 it is kept for sale in bulk, said oleomargarine must be 14 wrapped in wrappers plainly stamped or printed on the 15 outside thereof with the word "oleomargarine" in plain 16 Gothic letters not less than twenty point size, and shall also 17 contain the name and address of the seller thereof and the 18 quantity sold. For the purpose of this act, any article, 19 substance or compound manufactured from animal fats or 20 oils, vegetable oils, or from compounds or mixtures of ani-21 mal fats or oils and vegetable oils which has been churned 22 in cream, milk or water or bathed in a solution of brine, 23 shall be considered oleomargarine. Nor shall any person, 24 firm or corporation within this state use in any way in 25 connection or association with the sale, or exposure for sale 26 or advertisement of any oleomargarine or any substance 27 designed to be used as a substitute for butter, the word 28 "butter," "creamery," or "dairy," or the name or repre-29 sentation of any breed of dairy cattle, or any combination 30 of such word or words and representation, or any other 31 words or symbols or combinations thereof commonly used 32 in the sale of butter,' so that said section six as amended 33 shall read as follows:

'Sect. 6. Imitations of butter or cheese not to be manu-2 factured or sold. No person shall manufacture, sell, ex-3 pose for sale or have in his possession with intent to sell,

4 or take orders for the future delivery of any article, sub-5 stance or compound made in imitation of yellow butter or 6 cheese, and not made exclusively and wholly of cream or 7 milk, or containing any fats, oil or grease not produced 8 from milk or cream, whether said articles, substance or 9 compound be named oleomargarine, butterine, or otherwise 10 named. Nor shall any person, firm or corporation sell, ex-II pose for sale, or have in his possession with intent to sell 12 oleomargarine unless the original package in which same 13 is shipped or conveyed from place of manufacture shall 14 have the word "oleomargarine" in letters three-quarters 15 inch high and of proportionate width plainly printed or 16 stencilled on the top or side thereof and unless each car-17 ton or wrapper containing said oleomargarine and in which 18 such oleomargarine is sold or kept for sale shall have the 19 word "oleomargarine" printed on two principal display 20 panels in plain Gothic letters not less than twenty point 21 type. When said oleomargarine is sold from a tub or box 22 or other container in which it is kept for sale in bulk, said 23 oleomargarine must be wrapped in wrappers plainly stamped 24 or printed on the outside thereof with the word "oleomar-25 garine" in plain Gothic letters not less than twenty point 26 size, and shall also contain the name and address of the 27 seller thereof and the quantity sold. For the purpose of 28 this act, any article, substance or compound manufactured 29 from animal fats or oils, vegetable oils, or from compounds 30 or mixtures of animal fats or oils and vegetable oils which

31 has been churned in cream, milk or water or bathed in a 32 solution of brine, shall be considered oleomargarine. Nor 33 shall any person, firm or corporation within this state use 34 in any way in connection or association with the sale, or 35 exposure for sale or advertisement of any oleomargarine 36 or any substance designed to be used as a substitute for but-37 ter, the word "butter," "creamery," "dairy," or the name 38 or representation of any breed of dairy cattle, or any com-39 bination of such word or words and representation, or any 40 other words or symbols or combinations thereof commonly 41 used in the sale of butter.'
