STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-SEVEN

AN ACT Relating to School Supervisory Unions.

Be it enacted by the People of the State of Maine, as follows:

Paragraph two of section fifty-seven of chapter one hundred
2 dred eighty-eight of the public laws of nineteen hundred
3 seventeen as amended by chapter eighteen, section three, of
4 the public laws of nineteen hundred nineteen is hereby
5 amended by striking out after the words "equal to" in line
6 eleven the word "twice" and inserting the word 'one-half'
7 and by striking out after the word "exceed" in line thir-
8 teen the word "eight" and inserting the word 'twelve,' and
9 after the word "year" in line thirteen insert 'nor shall any
10 school union receive less than one thousand,' so that section
11 fifty-seven will read as follows:

'Sect. 2. *Return to be made on or before August first, 2 nineteen hundred eighteen, and annually thereafter. Union 3 superintendents to be paid out of sum specifically appro- 4 priated for that purpose. The chairman and secretary of 5 said joint committee shall, upon the election of a superin- 6 tendent of schools as provided by the preceding section, 7 certify under oath to the state superintendent of public 8 schools, upon the forms prescribed by him, all facts rela- 9 tive to said union and employment of a superintendent. On 10 or before the first day of August, nineteen hundred eighteen, 11 and annually thereafter, and whenever a new superintendent 12 is chosen said chairman and secretary shall make return of 13 a similar certificate. Upon approval of said certificate the 14 superintendent so employed shall, on presentation of proper 15 vouchers, receive monthly out of the sum appropriated for 16 superintendence of towns composing school unions a sum 17 equal to one-half the aggregate sum paid by the towns com- 18 posing the union, provided, that the amount so paid for the 19 benefit of a single union of towns shall not exceed twelve 20 hundred dollars in one year, nor shall any school union re- 21 ceive less than one thousand, and provided further, that the 22 annual appropriation for payments hereunder shall be de- 23 ducted from state school funds.'*
