**AN ACT** Relating to the Salaries of the Judge and Recorder  
of the Bangor Municipal Court.

---

Be it enacted by the People of the State of Maine, as follows:

P. & S. L. 1895, c. 211, Sec. 11, as amended, relating to  
2 salary of judge and recorder and payment of expenses of  
3 Bangor municipal court, amended:

Section eleven of chapter two hundred and eleven of the  
2 private and special laws of eighteen hundred and ninety-five  
3 as amended by chapter one hundred one of the private and  
4 special laws of nineteen hundred and nine, as amended by  
5 chapter one hundred and forty-six of the private and special  
6 laws of nineteen hundred and fifteen, as amended by chapter  
7 thirty-three of the private and special laws of nineteen

8 hundred and nineteen, as amended by chapter forty-two of  
9 the private and special laws of nineteen hundred and twenty-  
10 three is further amended by striking out the words "eighteen  
11 hundred" and "seventeen hundred and fifty" in the eighth  
12 line thereof and inserting in place thereof the words 'twenty-  
13 one hundred' and 'eighteen hundred and fifty,' so that said  
14 section, as amended, shall read as follows:

'Sect. 11. Salary of Judge and Recorder increased to  
2 \$2,100 and \$1850 respectively. Said court shall be held at  
3 such places as the city of Bangor shall provide and said city  
4 shall have power and it shall be its duty to raise money and  
5 provide a proper place for said court and its officers and  
6 suitably furnish, warm and light the same, for which there  
7 shall be paid from the county of Penobscot as rental in  
8 quarterly payments, the sum of one thousand dollars annu-  
9 ally. The salaries of the judge and clerk thereof which are  
10 hereby fixed at twenty-one hundred dollars and eighteen  
11 hundred and fifty dollars respectively to be paid quarterly  
12 with all other expenses of said court, shall be paid from the  
13 treasury of the county of Penobscot and in addition thereof  
14 there shall be provided the sum of seven hundred and fifty  
15 dollars a year for clerk hire, to be paid monthly from said  
16 treasury, provided, however, that the county commissioners  
17 of said county may in their discretion, expend a larger  
18 amount not exceeding five hundred dollars per year, for the  
19 employment of extra clerks.'
