IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-SEVEN

RESOLVE, in Favor of the Maine State Prison for Maintenance and Current Expenses.

---

Resolved: That there be, and hereby is, appropriated for  
2 the Maine State Prison for the fiscal year from July first,  
3 nineteen hundred twenty-seven, to June thirtieth, nineteen  
4 hundred twenty-eight, the sum of eighty-seven thousand two  
5 hundred fifty dollars for the purposes hereinafter specified,  
6 namely:

JULY 1, 1927—JUNE 30, 1928

Personal services of officers and employees, fifty-

five thousand dollars,

\$55,000.00

Maintenance, including food supplies, clothing,  
 repairs and equipment, and general expenses,  
 twenty-eight thousand dollars, 28,000.00

Retiring and pensioning prison officials, two thou-  
 sand two hundred fifty dollars, 2,250.00

Permanent improvement, two thousand dollars, 2,000.00

And be it further resolved that there be, and hereby is,  
 2 appropriated for the Maine State Prison for the fiscal year  
 3 from July first, nineteen hundred twenty-eight, to June thir-  
 4 tieth, nineteen hundred twenty-nine, the further sum of  
 5 eighty-seven thousand two hundred fifty dollars for the pur-  
 6 pose hereinafter specified, namely:

JULY 1, 1928—JUNE 30, 1929

Personal services of officers and employees, fifty-  
 five thousand dollars, \$55,000.00

Maintenance, including food supplies, clothing,  
 repairs and equipment, and general expenses,  
 twenty-eight thousand dollars, 28,000.00

Retiring and pensioning prison officials, two thou-  
 sand two hundred fifty dollars, 2,250.00

Permanent improvement, two thousand dollars, 2,000.00
