STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Establish the Legal Length Limit of Squaretailed Trout and Land-locked Salmon in Cumberland County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful for any person at any

- 2 time to take or catch and kill any square-tailed trout less
- 3 than ten inches in length, or any land-locked salmon less
- 4 than fourteen inches in length, in any lake or pond situated
- 5 wholly or partly in the county of Cumberland.

It shall also be unlawful for any person to have in pos-2 session at any time any square-tailed trout less than ten

- 3 inches in length, or any land-locked salmon less than four-
- 4 teen inches in length, taken in any lake or pond situated
- 5 wholly on partly in said Cumberland county.
 - Sect. 2. Whoever violates any provision of this act shall
- 2 be subject to a penalty of not less than ten dollars nor more
- 3 than thirty dollars and costs for each offense, and one dollar
- 4 additional for each fish taken, caught, killed or had in pos-
- 5 session in violation of any provision of this act.
 - Sect. 3. In all prosecutions arising under this act, trial
- 2 justices, police and municipal courts within their counties
- 3 shall have upon complaint original and concurrent jurisdic-
- 4 tion with the supreme judicial court and superior courts.
- Sect. 4. All acts or parts of acts inconsistent with the 2 provisions of this act are hereby repealed.
