# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Regulate the Hunting of Wild Birds in the Waters of Merrymeeting Bay.

Be it enacted by the People of the State of Maine, as follows:

Section 1. A game sanctuary shall be established in

- 2 Merrymeeting Bay bounded as follows: On the north by
- 3 a line drawn from a marker at the head of Butler's Point
- 4 and running in a westerly direction to the north end of Big
- 5 Brick Island, thence southerly along the eastern shores of
- 6 Big and Little Brick Island to the south end of Little Brick
- 7 Island, thence southeasterly to a marker on the shore of
- 8 Black Water Cove and thence northerly along the shore
- 9 back to the original starting point.

Within this sanctuary it shall be unlawful at any time to 2 shoot, shoot at, molest or pursue game or game birds of any 3 description, providing, however, that boats may pass through 4 without incurring any penalty.

- Sect. 2. Not more than twelve live decoys shall be allowed 2 in any one flock in the waters of Merrymeeting Bay and its 3 tributaries. Only one flock at the same time may be placed 4 in the water by one boat, or blind. No flock of decoys shall 5 be placed nearer than fifty yards to a flock already set or 6 being set.
- Sect. 3. No boat shall be allowed in the waters of Merry2 meeting Bay and its tributaries for hunting purposes earlier
  3 than one and one-half hours before sunrise, nor shall any
  4 duck decoys be allowed to remain in said waters between
  5 the hours of sunset and one hour before sunrise.
- Sect. 4. Whoever violates any of the preceding sections 2 of this act shall pay a fine of not less than ten dollars nor 3 more than forty dollars for each offense and nothing in this 4 act shall be construed as changing the closed season on wild 5 birds from sunset to half an hour before sunrise the following morning.
